A PROCLAMATION

DETERMINING NEW DESIGNS FOR SILVER, CUPRO-NICKEL, MIXED METAL AND BRONZE COINS
GEORGE R.

Whereas by Our Proclamation dated the twenty-second day of June, 1948, We did appoint and declare that, so far as conveniently may be, on all occasions and in all instruments wherein Our Style and Titles are used, in the Latin tongue, the words "Indae Imperator," and, in the English tongue, the words "Emperor of India" shall be omitted:

And Whereas under section eleven of the Coinage Act, 1870, We have power, with the advice of Our Privy Council, from time to time by Proclamation to determine the design for any coin:

And Whereas it appears to Us desirable to determine new designs accordingly for the coins hereinafter specified, being certain of the silver and bronze coins mentioned in the First Schedule to the Coinage Act, 1870, and of the cupro-nickel coins mentioned in the Schedule to the Coinage Act, 1946, and the coin of mixed metal mentioned in Our Proclamation dated the eighteenth day of March, 1937:

We, therefore, in pursuance of the said section eleven and of all other powers enabling Us in that behalf, do hereby, by and with the advice of Our Privy Council, proclaim, direct and ordain as follows:—

1. The designs for the said cupro-nickel, silver and bronze coins and the said coin of mixed metal shall be as follows:—

CUPRO-NICKEL COINS

Half-Crown.—Every half-crown shall have for the obverse impression Our effigy, with the inscription "GEORGIUS VI D:G:BR:OMN:REX," and for the reverse the Ensigns Armorial of the United Kingdom contained in a Shield having on each side the initial letter of Our Name in duplicate and interlaced surmounted by the Royal Crown, with the inscription "FID. DEF." together with the words "HALF CROWN," and the date of the year. The coin shall have a graining upon the edge.

Florin.—Every florin shall have the same obverse impression and inscription as the half-crown, and for the reverse a Rose, Thistle and Shamrock, surmounted by a Crown; and the letters "G" and "R" below; with the inscription "FID:DEF:", together with the words "TWO SHILLINGS" and the date

of the year. The coin shall have a graining upon the edge.

Shilling.—Every shilling shall have the same obverse impression and inscription as the half-crown, and for the reverse either

(a) Our Royal Crest of England
or

(b) Our Royal Crest of Scotland,
with the inscription "FID. DEF." together with the words "ONE SHILLING" and the date of the year. The coin shall have a graining upon the edge.

Sixpence.—Every sixpence shall have the same obverse impression and inscription as the half-crown, and for the reverse Our Royal Cipher surmounted by a Crown, with the inscription "FID. DEF." together with the word "SIXPENCE" and the date of the year. The coin shall have a graining upon the edge.

SILVER COINS

The King's Maundy Monies.—Every Maundy silver fourpence, threepence, twopence and penny shall have for the obverse impression Our aforesaid effigy, with the inscription "GEORGIUS VI D:G:BR:OMN:REX FIDEI DEF." and for the reverse the respective figures "4," "3," "2," "1" (according to the denomination or value of the piece), in the centre, with the date of the year placed across the figure, and encircled with an oak wreath surmounted by the Royal Crown. The coins shall have a plain edge.

COIN OF MIXED METAL

Threepence.—Every threepence of mixed metal shall have for the obverse impression Our effigy with the inscription "GEORGIUS VI D:G:BR:OMN:REX FIDEI DEF." and for the reverse impression a representation of the Plant commonly known as "Thrift," together with the words "THREE PENCE" and the date of the year. The coin shall have an edge having twelve sides.

BRONZE COINS

Penny.—Every penny shall have for the obverse impression Our effigy with the inscription "GEORGIUS VI D:G:BR:OMN:REX FIDEI DEF." and for the reverse impression the figure of Britannia seated on a rock surrounded by the sea, her right hand holding a shield which rests against the rock, while in her left hand she grasps a trident, with a Lighthouse in the distance; and the words "ONE PENNY," with the date of the year. The coin shall have a plain edge.

Half-penny.—Every half-penny shall have the same obverse impression and inscription as the penny, and for the reverse the representation of a sailing ship, and the words "HALF PENNY" with the date of the year. The coin shall have a plain edge.

Farthing.—Every farthing shall have the same obverse impression and inscription as the penny, and for the reverse the representation of a Wren, and the word "FARTHING" with the date of the year. The coin shall have a plain edge.

2. This Proclamation shall come into force on the first day of January One thousand nine hundred and forty-nine.

Given at Our Court at Buckingham Palace this twenty-second day of December, in the year of our Lord One thousand nine hundred and forty-eight, and in the Thirteenth year of Our Reign.

STATUTORY RULES AND ORDERS OF NORTHERN IRELAND, 1948. No. 325

SUMMONS AND PROCESS SERVERS' FEES

Order, dated 21st December, 1948, made by the Lord Chief Justice of Northern Ireland, under section one of the Summons and Process Servers' Fees (Ireland) Act, 1919.

Whereas by section one of the Summons and Process Servers' Fees (Ireland) Act, 1919, it is provided in effect that the Lord Chief Justice of Northern Ireland may make Orders prescribing:—

- the maximum sums that may be fixed by justices under section ten of the Petty Sessions Clerks and Fines (Ireland) Act, 1878, as fees for the service of summonses under the Summary Jurisdiction Acts; and
- the fees that may be charged under section eighteen of the Civil Bill Courts (Ireland) Act, 1851, for the service of County Court processes.

Now, therefore, I, the Right Honourable Sir James Andrews, Bart., Deputy Lieutenant, Lord Chief Justice of Northern Ireland, in pursuance of the powers vested in me by the said section and of all other powers thereunto me enabling, do hereby make the following Order:—

- Any summons server appointed under the Summary Jurisdiction Acts (Northern Ireland) shall be entitled to be paid by the complainant or person for whom he may be employed such sum, not exceeding the sum specified for each

case in the First Schedule to this Order annexed, according to the distance necessarily travelled by such summons server in effecting every such service upon each party or witness (or upon any number of parties or witnesses in the same case who shall be served in the same house) as the resident magistrate shall fix.

2. Any process server appointed in pursuance of section fifteen of the Civil Bill Courts (Ireland) Act, 1851, shall, in addition to any salary made payable to him under that Act, be entitled to be paid the fees set forth in the Second Schedule to this Order annexed.
3. The Order made by the Lord Chancellor of Ireland dated 19th May, 1919, is hereby revoked.
4. This Order may be cited as the Summons and Process Servers' Fees Order (Northern Ireland), 1948, and shall have effect as from 1st January, 1949.

FIRST SCHEDULE

Maximum Fees Payable to Summons Servers

Where the distance travelled shall not exceed two miles—2s. 0d.

Where the distance travelled shall not exceed four miles—3s. 0d.

Where the distance travelled shall exceed four miles—such sum not exceeding 6s. 0d. as may be arranged between the complainant and the summons server.

The distance to be reckoned in each case to the place of service from the Petty Sessions Court of the district, and the return journey is not to be taken into account.

SECOND SCHEDULE

Maximum Fees Payable to Process Servers

Serving Civil Bill in any case where there is but one defendant, or there are several defendants residing in the same dwelling-house:—

Where the amount sought to be recovered shall not exceed £10—2s. 0d.

Where the amount sought to be recovered shall not exceed £50—3s. 0d.

Where the amount sought to be recovered shall exceed £50—4s. 0d.

In case of two or more defendants not residing in one and the same dwelling-house, a separate fee for each defendant:—

Where the amount sought to be recovered shall not exceed £10—1s. 6d.

Where the amount sought to be recovered shall not exceed £50—2s. 0d.

Where the amount sought to be recovered shall exceed £50—2s. 6d.

In all cases in which personal service is necessary the fees for service shall be increased by one-third the above allowance.
