CIVIL AUTHORITIES (SPECIAL POWERS) ACTS (NORTHERN IRELAND) 1922 to 1943

Whereas there is reason to believe that assemblies of persons have been or are about to be convened for the purpose of holding meetings, assemblies or processions in Northern Ireland to commemorate the rebellion of Easter Week, 1916, or to mark the establishment of a Republic in a part of Ireland, or for the promotion of the objects of the Irish Republican Army or any other unlawful Association:

And whereas there is reason to apprehend that such assemblies of persons and the holding of such meetings, assemblies or processions will give rise to grave disorder or conduce to a breach of the peace or promote disaffection and thereby cause undue demands to be made upon the Police Force:

Now, therefore, I, the Right Honourable Edmond Warnock, K.C., M.P., Minister of Home Affairs for Northern Ireland, being the Civil Authority under the Civil Authorities (Special Powers) Acts (Northern Ireland), 1922 to 1943, do hereby, in accordance with the provisions of Regulation 4 of the Regulations made under the authority of the said Acts, prohibit the holding of any such assemblies, meetings or processions in Northern Ireland on the 17th and 18th April, 1949.

POSTPONEMENT OF LOCAL GOVERNMENT ELECTIONS Order, dated 8th April, 1949, made by the Ministry of Home Affairs under section forty-seven of the Elections and Franchise Act (Northern Ireland), 1946 (Reprint to 1948).

Whereas it is provided by section forty-seven of the Elections and Franchise Act (Northern Ireland), 1946 (Reprint to 1948) (hereinafter referred to as "the Act") that where there is in force an Order under section fourteen of the Act postponing the date of publication of a Register, or part thereof, the Ministry of Home Affairs (hereinafter referred to as "the Ministry") may, by a further Order, direct that for any day fixed under section forty-six of the Act for nomination or election of candidates in any Local Government Election to which that Register, or part, relates, there shall be substituted such other day (not being later than three months after the day so fixed) being later than three months after the day so fixed) as may be specified in the Order; and any such order

may contain such consequential provisions as may be necessary for giving effect to the said section:

April: And whereas it is deemed expedient to postpone the date fixed for nomination and election of can-

didates to the councils of the urban districts of Carrickfergus and Lurgan respectively:

Now, therefore, the Ministry, in exercise of the powers vested in it by section forty-seven of the Act and of every power in that behalf thereunto enabling the Ministry, hereby makes the following Order:—

1. In the year 1949, for the day fixed under section forty-six of the Act for nomination of candidates for elections to the council of an urcandidates for elections to the council of an urban district, there shall, as respects the urban districts of Carrickfergus and Lurgan, be substituted the third day of August, nineteen hundred and forty-nine, and where such elections are contested for the day fixed under the said section for the holding of the poll, there shall be substituted the seventeenth day of August, nineteen hundred and forty-nine

substituted the seventeenth day of August, nine-teen hundred and forty-nine.

2. In the year 1949, for the day fixed in paragraph (c) of sub-section (1) of section forty-nine of the Act for the holding of the annual meeting and election of the chairman and vice-chairman of the council of an urban district, there shall, as respects the urban districts of Car-rickfergus and Lurgan be substituted a day not rickfergus and Lurgan, be substituted a day not being less than four and not more than eleven days after the seventeenth day of August, nineteen hundred and forty-nine.

3. This Order may be cited as the Local Government Elections (Carrickfergus and Lurgan) (Postponement) Order (Northern Ireland), 1949.

Article one of the principal Order shall have effect in relation to the Registration Units of the Register in respect of the Administrative County of Londonderry, referred to in the Schedule hereto, as if for the reference therein to the fourteenth day of April there was substituted a reference to the twenty-eighth day of April

2. Sub-paragraph (a) of paragraph (7) of Regulation nineteen of the Electoral (Local Government Elections) Regulations (Northern Ireland), 1949, as amended by the principal Order, shall have effect, in relation to the Registration Units referred to in the Schedule hereto, as if for the words "the publication of a Register in any publication year" there was substituted the words "the fourteenth day of April, Nineteen Hundred and Forty-nine." 3.
