STATUTORY RULES AND ORDERS OF NORTHERN IRELAND 1949, No. 96

INTOXICATING LIQUOR COMPENSATION: CHARGES IN RESPECT OF LICENCES

Order, dated 10th June, 1949, made by the Ministry of Finance under Section 3 of the Intoxicating Liquor

Act (Northern Ireland) 1923, as amended by the Intoxicating Liquor (Finance) Act (Northern Ireland), 1925, and by the Exchequer and Financial Provisions (No. 2) Act (Northern Ireland), 1936.

In pursuance of sub-sections 3(b) and (4) of section three of the Intoxicating Liquor Act (Northern Ireland), 1923, as amended by the Intoxicating Liquor (Finance) Act (Northern Ireland), 1925, and by the Exchequer and Financial Provisions (No. 2) Act (Northern Ireland), 1936, the Ministry of Finance hereby prescribes that the rates at which charges are to be levied in respect of all licences for the sale of intoxicating liquor by retail granted or renewed during the year ending the 30th day of September, 1950, shall be fourteen shillings and tenpence for each pound sterling of the maximum rates of charge authorised by sub-section (1) of section one of the Intoxicating Liquor (Finance) Act (Northern Ireland), 1925.

EXPLANATORY NOTE

(This note is not part of the Order, but is intended to indicate its general purport).
