(Classes of employment specified as being of a subsidiary nature only and, therefore, excluded from being employment within the meaning of Part I of the National Insurance Act, 1911, and the Unemployment Insurance Act, 1920).

EMPLOYMENT UNDER THE POST-MASTER-GENERAL.

Employment as a telephone exchange attendant, residing elsewhere than on the exchange premises, giving service only at night or on Sunday.

Employment as a part-time telephonist (day or night).

Employment as an auxiliary postman.

Employment as an auxiliary sorter.

Employment as a part-time indoor assistant for postal and telegraph business.

SECOND SCHEDULE.

(Conditions under which persons engaged in the classes of employment specified in the First Schedule are included amongst the persons employed within the meaning of Part I of the National Insurance Act, 1911, and the Unemployment Insurance Act, 1920).

Any person employed as a telephone exchange attendant who is mainly dependent for his livelihood on the earnings derived by him from such employment or from any one or more part-time employments under the Postmaster-General.

Any person employed as a part-time telephonist (day or night), auxiliary postman, auxiliary sorter or part-time indoor assistant for postal and telegraph business who renders on the average eighteen or more hours' service weekly in any one or more part time employments under the Postmaster-General.

WHEREAS the Ministry of Home Affairs for Northern Ireland by an Order under Seal entitled the County and Rural District Councillors (Northern Ireland) Election Order, 1924, (hereinafter referred to as "the Principal Order") did order and direct that until the Ministry otherwise orders the rules contained in the said Order should be observed in connection with the election of county and rural district councillors in Northern Ireland:

And whereas it is expedient to amend and vary the Principal Order in manner hereinafter appearing:

Now therefore the Ministry of Home Affairs for Northern Ireland in exercise of every power in this behalf enabling the Ministry, hereby orders that the Principal Order shall be amended and varied in manner following, that is to say:—

1. For sub-sections (4) and (5) of Rule 1 of the Principal Order the following shall be substituted :—

(4) The Returning Officer may, in writing, appoint a fit person or persons to be his Deputy or Deputies for all or any of the purposes relating to the election of County or Rural District Councillors, provided that, so far as regards the carrying out of this Order in respect of the election of Rural District Councillors in Rural Districts, he shall in every case appoint a Deputy, and the Clerk of the Rural District Council shall be the Deputy so appointed.

(5) In every county electoral division containing an urban district the Returning Officer shall appoint the Clerk of the Urban District Council as his Deputy for all purposes for which a Deputy may be required in connection with the election of a County Councillor or Councillors for the part of the county electoral division, which comprises the Urban District. 2. This Order may be cited as the County and Rural District Councillors (Northern Ireland) No. 2 Election Order, 1924, and shall be construed as one with the County and Rural District Councillors (Northern Ireland) Election Order, 1924. applies to the County Borough of Belfast: Now therefore the Ministry of Home Affairs for Northern Ireland in exercise of the powers vested in it by the Local Government Acts (Northern Ireland), 1898 to 1923, and of all other powers enabling the Ministry in that behalf, hereby orders and directs that the Order in so far as it applies to the County Borough of Belfast shall be amended and varied as follows, that is to say:—

DAY OF ELECTION.

1. The day of election shall be such one of the days fixed by the Councils of the Counties of Antrim and Down for the election of Rural District Councillors in their respective Counties as the Council of the County Borough of Belfast may determine.

2. Rule 31 of the Order shall be varied so as to read as hereunder set forth.

31. Any public notice required by this Order shall be given by posting copies of the same at every courthouse, police station, market house, and other usual place for posting public notices within the district electoral division.

3. This Order may be cited as the Belfast Guardians (Northern Ireland) Election Order, 1924.

(Investing Council with Urban Powers for Lighting Markethill and determining Area of Charge).

MINISTRY OF HOME AFFAIRS FOR NORTHERN IRELAND.

RURAL DISTRICT OF ARMAGH.

To the Council of the Administrative County of Armagh; to the Council of the Rural District of Armagh; and to all others whom it may concern:

WHEREAS by Section I of the Public Health (Ireland) Act, 1896, as adapted, it is enacted in effect that the Ministry of Home Affairs for Northern Ireland (hereinafter re-ferred to as the Ministry), may, on the application of the Sanitary Authority of any rural district, by Order to be published in the Belfast Gazette, or in such other manner as the said Ministry may direct, declare any provisions of the Public Health (Ireland) Acts, 1878 to 1890, in force in Urban Districts to be in force in such Rural District or any contributory place therein, and may invest such authority with all or any of the powers, rights, duties, capacities, liabilities, and obligations of an Urban Authority under those Acts, and that such investment may be made either unconditionally or subject to any conditions to be specified by the Ministry, as to the time, portion of the district, or manner, during at, and in which such powers, rights, duties, liabilities, capacities, and obligations are to bé exercised and attach:

And whereas it is enacted by Section 22 of the Local Government (Ireland) Act, 1898, that all Urban Sanitary Authorities shall be called Urban District Councils, and that for every Rural Sanitary District there shall be a Rural District Council whose district shall be called a Rural District:

And whereas it is enacted by sub-section (1) of Section 33 of the said Local Government Act that there shall be transferred to the District Council of every Rural District the business of the Rural Sanitary Authority in the District:

And whereas it is enacted in effect by Section 232 of the Public Health (Ireland) Act, 1878, as adapted, that special expenses (as defined in the said Section 232) shall be (amongst others) the expenses of lighting where duly authorised; that special expenses shall be a separate charge on some contributory place or places; that a townland is a contributory place or places; that a townland is a contributory place; and that the Ministry of Home Affairs for Northern Ireland shall have power to determine on what area of charge, being a contributory place, or consisting of contributory places, any special expenses shall be chargeable;

And whereas the Council of the Rural District of Armagh has made application to the Ministry, under the said Section 1 of the Public Health (Ireland) Act, 1896, for an Order declaring the provisions of Section 80 of the said Public Health (Ireland) Act, 1878, in force in Urban Districts to be in force in the said Rural District:

Now therefore the Ministry of Home Affairs for Northern Ireland in exercise of the powers vested in it by the Public Health (Ireland) Acts, 1878 to 1919, as adapted, and by all other statutes in this behalf enabling the Ministry hereby Orders, declares, and determines as follows, that is to say:— 1. The provisions of Section 80 of the Public Health (Ireland) Act, 1878, are declared to be in force within the area consisting of the Townlands of Coolmillish, Edenykennedy, Crunaght and Gosford Demesne in the Rural District of Armagh, and subject to any conditions which the Ministry may hereafter deem fit to specify in the matter, and to the provisions as to rating in Rural Districts of the Local Government (Northern Ireland) Acts, 1898 to 1923, the Council of the Rural District of Armagh is hereby invested with all the powers, rights, duties, capacities, liabilities and obligations of an Urban District Council under Section 80 of the Public Health (Ireland) Act, 1878, to be exercised and attach within the limits or boundaries of the aforesaid area.

The Townlands of Coolmillish, Edenykennedy, Crunaght and Gosford Demesne are hereby determined to be the area of charge upon which all expenses incurred by the Council of the Rural District of Armagh in carrying out the provisions of Section 80 of the said Public Health (Ireland) Act, 1878, within the said area shall be chargeable.
