RYEGRASS SEED

Order in Council, dated the 30th March, 1950, made under Sub-section (3) of Section Thirteen of the Ryegrass Seed (Temporary Provisions) Act (Northern Ireland), 1949.

AND WHEREAS an Address has been presented to the Governor of Northern Ireland by each House of Parliament praying that the said Act should be continued in force for a further period of one year from the time at which it would otherwise expire:

Now, therefore, I, William Spencer, Earl Gran-ville, Knight Commander of the Royal Victorian Order, Companion of the Most Honourable Order of the Bath, Companion of the Distinguished Pervice Order, Vice-Admiral, Governor of Northern Ireland, by and with the advice of the Privy Council of Northern Ireland, in exercise of the powers conferred upon me by paragraph (a) of Sub-section (3) of Section Thirteen of the Ryegrass Seed (Temporary Provisions) Act (Northern Ireland), 1949, do hereby order and direct that the said Act be continued in force until the thirty-first day of July, nineteen hundred and fifty-one.
