Dangerous Drugs

Order in Council, dated 12th June, 1950, made under Sub-section (2) of Section Eight of The Dangerous Drugs Act, 1920, as amended by Subsection (2) of Section One of The Dangerous Drugs Act (Northern Ireland), 1932.

By The Governor in the Privy Council of Northern Ireland

GRANVILLE

WHEREAS by sub-section (2) of section eight of the Dangerous Drugs Act, 1920 (hereinafter referred to as "the principal Act") as amended by sub-section (2) of section one of the Dangerous Drugs Act (Northern Ireland), 1932, power is conferred upon the Governor of Northern Ireland by Order in Council to declare that Part III of the principal Act shall apply to any drug of whatever kind in the same manner as it applies to the Drugs mentioned in

sub-section (1) of the said section eight if it appears to him that the drug is or is likely to be productive, if improperly used, or is capable of being converted into a substance which is or is likely to be productive, if improperly used, of ill effects substantially of the same character or nature as or analogous to those produced by morphine or cocaine:

AND WHEREAS it appears to the Governor of Northern Ireland that the drugs specified in the Schedule to this Order are productive, if improperly used, or are capable of being converted into a substance which is or is likely to be productive, if improperly used, of ill effects substantially of the same character or nature as or analogous to those produced by morphine or cocaine:

AND WHEREAS by the Dangerous Drugs Act (Application) Order (Northern Ireland), 1948, made under the aforesaid powers, it was declared that Part III of the principal Act should apply as aforesaid to, amongst other drugs, a certain form of the drug known as amidone, and its salts, and preparations, admixtures, extracts or other substances containing any proportion of that form of amidone:

AND WHEREAS all forms of the drug known as amidone, and its salts, and preparations, admixtures, extracts and other substances containing any proportion of any form of amidone are amongst the drugs specified in the Schedule to this Order, and its should be amended so as to omit reference to the said form of amidone, and its salts, and preparations, admixtures, extracts or other substances containing any proportion of the said form of amidone:

AND WHEREAS by section four of the Dangerous Drugs Act (Northern Ireland), 1932, an Order made by the Governor of Northern Ireland in Council under the principal Act as amended by the said Act of 1932, may be varied or revoked by a subsequent Order made in the like manner and subject to the like provisions:

INTOXICATING LIQUOR

COMPENSATION: CHARGES IN RESPECT OF LICENCES

Order, dated 8th June, 1950, made by the Ministry of Finance under Section 3 of the Intoxicating Liquor Act (Northern Ireland), 1923, as amended by the Intoxicating Liquor (Finance) Act (Northern Ireland), 1925, and by the Exchequer and Financial Provisions (No. 2) Act (Northern Ireland), 1936.

- 1. In pursuance of sub-sections 3(b) and (4) of section three of the Intoxicating Liquor Act (Northern Ireland) 1923, as amended by the Intoxicating Liquor (Finance) Act (Northern Ireland), 1925, and by the Exchequer and Financial Provisions (No. 2) Act (Northern Ireland), 1936, the Ministry of Finance hereby prescribes that the rates at which charges are to be levied in respect of all licences for the sale of intoxicating liquor by retail, granted or renewed during the year ending the 30th day of September, 1951, shall be fourteen shillings and tenpence for each pound sterling of the maximum rates of charge authorised by sub-section (1) of section one of the Intoxicating Liquor (Finance) Act (Northern Ireland), 1925.
