Now I, James Albert Edward, Governor of Northern Ireland, in pursuance of the powers conferred upon me by the above-mentioned Acts, and all other powers me thereunto enabling, do hereby order and declare that the Petty Sessions Districts of Fintona and Dromore, both in County Tyrone, shall from the 1st day of June, 1924, be served by one and the same person as Clerk.

TRADE BOARDS ACT (NORTHERN IRELAND), 1923. RETAIL BESPOKE TAILORING TRADE BOARD

(NORTHERN IRELAND).

CIVIL AUTHORITIES (SPECIAL POWERS) ACT (NORTHERN IRELAND), 1922.

WHEREAS by an Order made by me on the 6th day of April, 1923, all persons within the area of Northern Ireland were ordered and required to remain within doors between the hours of 12 o'clock midnight and 5 o'clock a.m., unless provided with a permit in writing from an Officer of the Royal

Ulster Constabulary, as therein specified, and the said Order is still in force:

Now I, the Right Honourable Sir Richard Dawson Bates, Minister of Home Affairs for Northern Ireland, being the Civil Authority under the Civil Authorities (Special Powers) Act (Northern Ireland, 1922, by virtue of the powers vested in me by the said Act and the Regulations made thereunder, and of all other powers enabling me in this behalf, Do Hereby Vary the said Order in so far that within the County of the City of Londonderry all persons are ordered and required to remain within doors between the hours of 11 o'clock p.m. and 5 o'clock a.m., unless provided with a permit in writing from the Commissioner of Police or a District Inspector, duly authorised by the Commissioner.

This Order shall come into force at 11 o'clock p.m. on the 23rd day of May, 1924.

Existing permits issued for the said County of the City of Londonderry, so long as they are in force, hold good for the periods stated in them and for the hours between 11 p.m. and 5 a.m.;

And the provisions of the said Order of the 6th day of April, 1923, shall remain in force in respect of all areas within Northern Ireland other than the said County of the City of Londonderry, and all the provisions of the said Order, other than those which are varied as hereinbefore specified, shall remain in force within the said County of the City of Londonderry.
