ABERCORN.

EDUCATION ACT (NORTHERN
IRELAND), 1923.

WHEREAS it is provided by Section one hundred and nine of the Education Act (Northern Ireland), 1923, (in this Order referred to as "the Act"), that the Act shall come into operation on the appointed day, and that the appointed day shall be such day, not being earlier than the first day of October, nineteen hundred and twenty-three, as the Governor of Northern Ireland may by Order in Council appoint, and that different days may be appointed for different purposes and for different provisions of the Act, for different education areas or parts of education areas, and for different persons or classes of persons:

And whereas the first day of October, 1923, was appointed by the said Governor by an Order in Council dated the twenty-seventh day of September, 1923, as the appointed day, subject as therein mentioned—

(a) for the purpose of the provisions of the Act relative to the exercise of powers and the performance of duties by any Minister or Ministry of Northern Ireland, and relative to the making of Orders in Council by the Governor of Northern Ireland; and

(b) for the purpose of the provisions of the Act mentioned in the Schedule to the said Order, so far as the said provisions relate to the education areas mentioned in that schedule, and to the extent specified therein:

And whereas the first day of April, 1924, was appointed by the said Governor by an Order in Council dated the twenty-sixth day of March, 1924, as the appointed day for the purpose of the provisions of the Act mentioned in the Schedule to the said Order, so far as the said provisions relate to the education areas mentioned in that Schedule, and to the extent specified therein:

Now I, James Albert Edward, Duke of Abercorn, Governor of Northern Ireland, by and with the advice of the Privy Council of Northern Ireland, do hereby order as follows:—

I appoint the first day of October, 1924, as the appointed day for the purpose of the provisions of the Act mentioned in the first column of the Schedule to this Order, so far as they relate to education areas consisting of counties, and to the extent specified in the second column of that Schedule.

And whereas the County Council after complying in all respects with the regulations prescribed by the Local Government Board for Ireland on the 25th day of July, 1899, in pursuance of the said Article 26 of the Order in Council, did at a meeting held on the 25th day of January, 1924, make the Order, which with certain modifications, is set forth in the Schedule hereunto annexed, and did submit the said Order to the Ministry of Home Affairs for Northern Ireland:

And whereas no petition to disallow the said Order of the County Council has been presented to the Ministry of Home Affairs for Northern Ireland from the Council of any district affected by the Order, or any sufficient number of Local Government Electors within the Urban County District of Bangor within three months of the first notice as determined by the said Order of the Local Government Board for Ireland:

Now therefore, the Ministry of Home Affairs for Northern Ireland, in exercise of every power in this behalf enabling the Ministry, hereby modifies and confirms the said Order of the County Council as set forth in the Schedule hereunto annexed and as hereunder directed, and declares that such modifications are necessary for carrying into effect the objects of the said Order of the County Council:—

1. The boundaries of the Urban County District of Bangor and of the Wards into which the said Urban County District is divided shall be those shown on the Map No. 1 and Map No. 2, adopted by the County Council, and respectively described in the First and Second Schedules to the said Order

of the County Council, provided that if there be any discrepancy between such descriptions and the said Maps, the Maps shall prevail, which Maps are executed in triplicate under the Seal of the Ministry of Home Affairs for Northern Ireland this 29th day of May, 1924:

2. The original Maps No. 1 and No. 2 shall be deposited in the Office of the Ministry of Home Affairs for Northern Ireland, and a sealed copy shall be deposited in the Office of the Clerk of the Urban County District of Bangor, and the said Clerk shall within one month of the date of the publication of this Order in the "Belfast Gazette" forward one certified copy of each of the Maps to the Commissioner of Valuation for Northern Ireland, to the Registrar-General for Northern Ireland, and to the Chief Superintendent, Ordnance Survey Office, Belfast:

3. The Order of the County Council as so modified, shall, subject to the provisions of this Order, come into force for the purposes of rating, from the 1st day of April, 1925, and for all other purposes from the 1st day of June, 1924:

4. Every person holding office on the 1st day of June, 1924, as County Councillor, District Councillor, or Guardian for any Electoral Area affected by this Order, and every County Councillor, District Councillor or Guardian elected for any such area, held before the 15th day of December, 1924, shall be deemed to have been elected for the Electoral Area as altered by this Order, and the County Council, District Council, or Board of Guardians of which he is a member shall be deemed to have been elected for the County District or Union as altered by this Order.

COUNTY COUNCIL OF DOWN. ORDER.

WHEREAS the Urban District Council of Bangor (hereinafter called the Urban Council)

duly made a Proposal to the County Council of the County of Down (hereinafter called the County Council) pursuant to Article 26 (1) of the Schedule to the Local Government (Application of Enactments) Order, 1898, for an Order for the Extension of the Boundary of the said Urban County District in manner therein specified, and for the alteration of the boundaries of the existing Five Wards into which the said Urban County District is divided consequent upon the proposed extension of the said Urban Boundary, with such modifications (if any) therein as the County Council should think fit.

And whereas the said Proposal was considered at a Meeting of the County Council held on the 3rd day of May, 1923, whereupon the County Council, being satisfied that a prima facie case had been made out for said Proposal, directed a Local Inquiry to be held by a Committee of the County Council, which Inquiry was duly held on the 27th day of June, 1923, after the publication of Advertisements and giving of Notices prescribed by the said Article 26 of the Schedule to the Local Government (Application of Enactments) Order, 1898, and by the Regulations bearing date the 25th July, 1899, made thereunder.

And whereas the said Committee reported to the County Council that it appeared to them desirable to grant a portion only of the extension of boundary applied for and the Urban Council has consented to accept such lesser extension in lieu of that specified in their Proposal.

Now, therefore, the County Council, in pursuance of the powers given to them by Article 26 of the Schedule to the Local Government (Application of Enactments) Order, 1898, and of all other powers them in that behalf enabling, do hereby Order as follows:—

1. The Boundary of the Urban County District of Bangor shall be altered and extended by including within the said Urban County District the area described in the First Schedule hereto, hereinafter referred to as the Transferred Area, being portion of the Rural County District of Newtownards, and comprising portions of the Townlands of Ballymacormick, Ballyholme, Ballymagee, Corporation, Ballyvarnet, Carnalea and Rathgael (otherwise Rathgill), and which is more particularly delineated on the Map No. 1, submitted to and adopted by the County Council this day, and signed by the Vice-Chairman and Secretary of the County Council, whereon so much of the Boundary of said added area as is not formed by high water mark of spring-tides is coloured Red.

2. The transferred area shall form part of the Urban County District of Bangor, and of the District Electoral Divisions of Ballymagee, Castle, Dufferin and Princetown, and shall cease to form part of the Rural County District of Newtownards and of the District Electoral Divisions of Crawfordsburn and Groomsport.

3. (1) For the purposes of any adjustments which may be required in consequence of this Order or of anything done thereunder, Article 30 of the Schedule to the Local Government (Application of Enactments) Order, 1898, shall apply, with the modification that where and so far as an adjustment is not or cannot be made under that Article by agreement between the authorities interested,

the Ministry of Home Affairs for Northern Ireland may, on the application of any of those authorities, make all such adjustments as shall appear to the Ministry to be requisite and proper, and every such adjustment made by the Ministry shall have full force and effect, notwithstanding any provisions to the contrary, contained in section 71 of the Local Government (Ireland) Act, 1898, or any Enactment amending that Section, or in any previous Adjustments Order, or any Award of the Commissioner of Public Works in Ireland (if any), or of the Ministry of Finance for Northern Ireland.

(2) Any sum which is applicable to the relief of any agricultural land, within the transferred area, from rates shall be paid by the County Council to the Urban Council in exchange for an adequate exemption of the said land from Rates, and any question which may arise as to the amount of the sum so applicable, or the date at which payment to the Urban Council, as aforesaid, shall commence, or otherwise in relation to said sum, shall, in the absence of agreement between the parties, be determined by the Ministry of Home Affairs for Northern Ireland.

4. (1) The provisions of any Public General Act adopted by the Urban Council and in force in the Urban District at the commencement of this Order, and any Order of the Privy Council of Ireland, or of the Privy Council of Northern Ireland, or of the Local Government Board for Ireland, or of the Ministry of Home Affairs for Northern Ireland, applicable to the Urban Council and in force at said date, shall apply to the Urban District, as extended by this Order, and references in any such Order of the Privy Council of Ireland, or the Privy Council of Northern Ireland, or the Local Government Board for Ireland, or the Ministry of Home Affairs for Northern Ireland, to the area comprised in the Urban District, prior to the commencement of this Order, shall be construed as references to the area comprised in the Urban District, as extended by this Order.

(2) Any bye-laws and regulations of the Urban Council which are in force in the Urban District at the commencement of this Order shall apply to the Urban District, as extended by this Order.

5. The Urban County District, as extended by this Order, shall be divided into Five Wards, named as follows:—

Now, Therefore, the Ministry of Home Affairs for Northern Ireland, in exercise of the powers vested in it by the public Health (Ireland) Acts, 1878 to 1919, as adapted, and by all other statutes in this behalf enabling the Ministry, hereby orders, declares and determines as follows, that is to say :—

1. The provisions of Section 80 of the Public Health (Ireland) Act, 1878, are declared to be in force within the area consisting of the Townlands of Cushendall, Kilnadore, Ballymacdoe, Faughill and Legg, in the Rural District of Ballycastle, and subject to any conditions which the Ministry may hereafter deem fit to specify in the matter and the provisions as to rating in Rural Districts of the Local Government Acts (Northern Ireland), 1898 to 1923, the Council of the Rural District of Ballycastle is hereby invested with all the powers, rights, duties, capacities, liabilities and obligations of an Urban District Council under Section 80 of the Public Health (Ireland) Act, 1878, to be exercised and attach within the limits or boundaries of the aforesaid area.

2. The Townlands of Cushendall, Kilnadore, Ballymacdoe, Faughill and Legg are hereby determined to be the area of charge upon which all expenses incurred by the Council of the Rural District of Ballycastle in carrying out the

provisions of Section 80 of the said Public Health (Ireland) Act, 1878, within the said area shall be chargeable.

AMENDING-REGULATION, DATED 27TH MAY, 1924, UNDER SECTION 29 OF THE REPRESENTATION OF THE PEOPLE ACT, 1918 (7 AND 8 GEO. 5, C. 64), IN ITS APPLICATION TO NORTHERN IRELAND, PRESCRIBING SCALE OF MAXIMUM CHARGES OF RETURNING OFFICERS AT ELECTIONS OF MEMBERS TO THE PARLIAMENT OF NORTHERN IRELAND.
