## POISONS

An Order in Council dated 26th February, 1951, has been made under Sub-Section (3) of Section twenty-six of the Medicines, Pharmacy and Poisons Act (Northern Ireland), 1945, approving resolutions passed by the Council of the Pharmaceutical Society of Northern Ireland and the Medical Faculty of the Queen's University of Belfast, declaring that the Third Schedule to the Medicines, Pharmacy and Poisons Act (Northern Ireland), 1945, ought to be amended by adding certain new substances.

##### PETTY SESSIONS DISTRICTS AND TIMES

Order, dated 26th February, 1951, made by the Ministry of Home Affairs under Sub-Section (1) of Section 10 of the Summary Jurisdiction and Criminal Justice Act (Northern Ireland), 1935.

WHEREAS by Order dated the 2nd day of August, 1950, the Ministry of Home Affairs, in exercise of the powers conferred upon it by Sub-Section (1) of Section 10 of the Summary Jurisdiction and Criminal Justice Act (Northern Ireland), 1935, temporarily abolished the Petty Sessions District of Bangor and made consequential arrangements for the holding in the Newtownards District of an additional sitting of Petty Sessions to hear such cases as would otherwise have been dealt with in the said abolished District.

AND WHEREAS it has been found possible to fix a convenient place within the District of Bangor at which Petty Sessions shall be held for that District:

NOW, THEREFORE, the said Ministry of Home Affairs, in pursuance of the powers conferred upon it by the said Sub-Section, hereby orders and directs that as and from the 15th day of March, 1951, the said Order of the 2nd day of August, 1950, shall be revoked and, accordingly, sittings of the Petty Sessions shall be resumed in the said District of Bangor as from the said date as though the Order hereby revoked had not been made.

##### WITHDRAWAL OF CERTIFICATE OF APPROVAL OF NAZARETH LODGE AS A TRAINING SCHOOL
