CLOSURE OF BALMORAL CEMETERY

NOTICE is hereby given that the Ministry of Health and Local Government for Northern Ireland, in exercise of the powers vested in it by the Public Health Acts (Northern Ireland), 1878 to 1946, has made an Order dated 7th June, 1951, requiring that burials shall be discontinued in the Balmoral Cemetery situated at Stockman's Lane, Belfast and prohibiting them from and after the 21st June, 1951, subject to certain exceptions specified in the Order.
