HEALTH, SAFETY AND WELFARE

The Ministry of Labour and National Insurance hereby gives Notice that on the 27th September, 1951, it made the Building Operations (First-Aid and Ambulance Room Equipment) Order (Northern Ireland), 1951, under Section 47 of the Factories Act (Northern Ireland), 1938.

The Order prescribes for the purposes of Regulation 80 of the Building Regulations (Northern Ireland)

1950, the equipment and materials to be contained in every first-aid box or case which that Regulation requires to be provided at certain building sites and the minimum standard of ambulance room equipment for the ambulance rooms thereby required to be provided and maintained.
