Now therefore Know Ye that We of Our Princely Grace and mere Motion have revoked and hereby do revoke Our said Warrant of the Thirtieth day of January, 1923; and We have ordained and declared and do by these Presents ordain and declare that all these our Loyal Subjects in Northern Ireland having Hereditary, Personal or Official rank shall have on all occasions place and precedence in Northern Ireland according to their respective positions in the Tables hereunto annexed, intituled The Scale of Local Precedence for Northern Ireland.

Our Will and Pleasure therefore it that you do cause this Our Warrant to be recorded in the Office of Ulster King of Arms, to the end that Our Officers of Arms and all others upon occasion may take full notice and have knowledge thereof.

Given at Our Court at Saint James's the Second day of July, 1924, in the Fifteenth Year of Our Reign.

SCALE OF LOCAL PRECEDENCE FOR NORTHERN IRELAND.

Noblemen and Gentlemen who have personal Precedence above that of their Official rank will take the higher Precedence. Officials of

the United Kingdom not mentioned in this Scale will take rank according to the Scale of General Precedence when in Northern Ireland.

The wife of the Governor of Northern Ireland will, unless she is entitled to higher Precedence in her own right, have Precedence next after the wives of the Nephews of the Sovereign. Any other Lady whose Husband's Precedence is governed by his Official rank will be granted that Precedence, unless she is entitled to higher Precedence in her own right. In all other cases the Scale of General Precedence will be followed.

TRADE BOARDS ACT (NORTHERN IRELAND), 1923.

ROPE, TWINE AND NET TRADE BOARD (NORTHERN IRELAND).

The Trade Board established under the powers vested in the Ministry of Labour for Northern Ireland and in pursuance of Section 8 of the Government of Ireland Act, 1920, and the enactments modified and adapted by the

Government of Ireland (Adaptation of Enactments) (No. 3) Order, 1921, and any other Order of His Majesty in Council made under the said Act of 1920 for those branches of the Rope, Twine and Net trade as defined in the Regulations of the said Ministry, dated Second day of January, 1922, hereby give Notice that they propose to fix general minimum time-rates for male workers employed in the trade in Northern Ireland.

On request to the Trade Board particulars of the proposed general minimum time-rates will be given if, in the opinion of the Trade Board, the applicant is likely to be affected thereby.

The Trade Board will consider any objections to their proposal to fix the said minimum rates which may be lodged with them within one calendar month from the fourth day of July, 1924. Such objection should be in writing, and signed by the person making the same (adding his or her full name and address), and should be sent to the Secretary of the Rope, Twine and Net Trade Board (Northern Ireland), 14 Bridge Street, Belfast. It is desirable that persons making objections should state precisely and, as far as possible, with reasons, what is objected to.

LAUNDRY TRADE BOARD (NORTHERN IRELAND).
