The Import Duties (Drawback) (No. 12) Order, 1952, which amends the present scheme for the allowance of drawback of Customs duty paid on : ---

(a) imported square-sawn wood and timber;

(b) imported veneers

used in the manufacture of certain sewing machine woodwork which is exported or shipped as stores.

To meet altered conditions, the rate of drawback for square-sawn wood and timber so used is increased from 8d, to 1s. 1d, per cubic foot, and the rate for veneers so used is decreased from 8s. to 5s. 9d, per cubic foot; stand legs and auxiliary tables are added to the list of manufactured articles on which drawback is payable; and amendments are also made to the quantities of imported mat-erials to be taken into account in calculating the drawback on the other articles in the Order.
