 - (a) if it is intended that the cost of the work, or the payment, specified in the application is to be a county-at-large charge or to be a charge on so much of the administrative county as comprises all the rural districts therein to the County
- 2. The Proviso to Article 6 of the Order is hereby annulled, and the following proviso substituted therefor:-

Provided that an application relating to any of the works specified in Section 56 of the Grand Juries (Ireland) Act, 1836, in so far as they do not relate to first-class roads or to second-class roads, shall, notwithstanding that the cost of the work is intended to be a county-at-large charge, be made to the Council of the district in which the work is locally situate:

3. This Order may be cited as the Local Government (Procedure of Councils)

(Northern Ireland) No. 2 Order, 1924, and shall be construed as one with the amended Order.
