WAGES COUNCILS ACT (NORTHERN IRELAND), 1945

Aerated Waters Wages Council (Northern Ireland)

The Aerated Waters Wages Council (Northern Ireland) hereby gives notice of its intention to submit to the Ministry of Labour and National Insurance proposals for the revocation of the Aerated Waters Wages Council (Northern Ireland) Wages Regulation (No. 2) Order, 1952 (S.R. & O., 1952, No. 222) and for the fixing of a statutory minimum remuneration in substitution for the statutory minimum remuneration at present payable,

Particulars of the proposals may be obtained from the Secretary of the Wages Council at the address given below.

The Wages Council will consider any written representations with respect to the above-mentioned proposals which may be sent to it within twenty-one days from 4th December, 1953. Any such representation should be signed by the person making the same (adding his or her address) and sent to the Secretary, Aerated Waters Wages Council (Northern Ireland), Tyrone House, Ormeau Avenue, Belfast. It is desirable that persons making objections should state the precise grounds of their objections.

RATES OF INTEREST ON LOANS ADVANCED FROM AGRICULTURAL LOANS FUND

It has been decided that the rates of interest charged on agricultural loans shall be reduced as from 1st December, 1953.

The new rates chargeable will be:

Loans repayable over a period not exceeding 10 years—5 per cent.

Loans repayable over a period exceeding 10 years $-5\frac{1}{2}$ per cent.

The new rates will apply to all loans approved on and after that date.
