# CIVIL AUTHORITIES

(SPECIAL POWERS) ACT (NORTHERN IRELAND), 1922.

WHEREAS by Section 10 of the Civil Authorities (Special Powers) Act (Northern Ireland), 1922, it is provided that the Minister of Home Affairs may by Order prohibit the

holding of Inquests by Coroners on dead bodies in any area in Northern Ireland specified in such Order, either absolutely or on such conditions as may be specified therein, and may provide for the duties of a Coroner and a Coroner's jury or either of them as respects any Inquests so prohibited being performed by such Officer or Court as may be determined by the Order, and that such Officer or Court shall have and may exercise for the purpose of any Inquiry directed to be held in pursuance of such Order or any report thereon all or any of the powers which might have been exercised by the Coroner or Coroner's jury for the purposes of every Inquest so prohibited and the finding thereon, whether conferred by Statute or at Common Law:

And Whereas by an Order made by me on the 20th day of April, 1922, the holding of Inquests by the Coroner on dead bodies was prohibited within the area of the County Borough of Belfast, and it was directed that the duties of the Coroner and the Coroner's jury as respects every Inquest so prohibited should be performed by means of an Inquiry to be held by James Graham, Esq., M.D., Coroner of the County Borough of Belfast:

And Whereas it is necessary to make further provision for the performance of the aforesaid duties:

Now I, The Right Honourable Sir Richard Dawson Bates, Minister of Home Affairs for Northern Ireland, do direct that during the illness of the said James Graham, Esq., M.D., or during his absence for any lawful or reasonable cause, or on any occasion on which if an Inquest were held the said James Graham, Esq., M.D., would be disqualified from holding the

same as Coroner, the duties of the Coroner and Coroner's jury as respects an Inquest prohibited as aforesaid may be performed by means of an Inquiry to be held by Thomas Kennedy, Esq., M.D., Deputy Coroner of the County Borough of Belfast, or by any Deputy Coroner duly appointed for the said County Borough in accordance with the provisions of the Coroner's (Ireland) Act, 1908, and I hereby determine the said Thomas Kennedy, Esq., M.D., or other Deputy Coroner as aforesaid to be an Officer to perform the said duties, and do direct that each of them severally shall have and may exercise for the purposes of any such Inquiry and his report thereon all and every of the powers, whether conferred by Statute or at Common Law, which might have been exercised by the Coroner or Coroner's jury for the purposes of every such Inquest so prohibited and the finding thereon:

This Order modifies the said Order of the 20th day of April, 1922, in so far as the aforesaid James Graham, Esq., M.D., was thereby appointed to be the sole person to hold an Inquiry as directed therein, but not otherwise.

THE HEAVY MOTOR CAR (NORTHERN IRELAND) (AMENDMENT) ORDER, 1924.

To the County Councils of the several Administrative Counties in Northern Ireland:

To the Councils of the several County Boroughs in Northern Ireland:

To the Urban District Councils of the several Urban County Districts in Northern Ireland:

And to all others whom it may concern:

WHEREAS in pursuance of Section 6 of the Locomotives on Highways Act, 1896, and Section 12 of the Motor Car Act, 1903, the Local Government Board for Ireland by the Heavy Motor Car (Ireland) Orders, 1905 and 1911, made certain regulations with respect to heavy motor cars:

And Whereas the powers of the said Local Government Board under the said Acts were under the Ministry of Transport Act, 1919, transferred to the Minister of Transport, and the said Minister did by the Road Vehicles (Registration and Licensing) Regulations, 1921, and the Heavy Motor Car (Amendment)

Order, 1921, amend the said regulations:

And Whereas, by virtue of the Government of Ireland Act, 1920, and certain orders made thereunder, the aforesaid powers with regard to services in Northern Ireland are now vested in the Ministry of Home Affairs for Northern

And Whereas it is expedient that a further regulation, as hereinafter set forth should be made in addition to the regulations aforesaid: Now, Therefore, the Ministry of Home Affairs for Northern Ireland, in exercise of its powers under Section 6 of the Locomotives on Highways

Act, 1896, and Section 12 of the Motor Car Act, 1903, and of all other powers in this behalf enabling the Ministry, hereby orders and directs as follows:

Article I.—The Heavy Motor Car (Ireland) Order, 1905, shall be read and have effect as if before Article XI. of that Order there were inserted the following Article, that is

to say:—

"Article Xb.—Every heavy motor car
used on any highway shall be fitted with a reflecting mirror so constructed and fixed and of such a character as will enable the person driving such heavy motor car to perceive the approach of any vehicle proceeding in the same direction and over-

taking such heavy motor car."

Article II.—This Order shall come into operation on, from and after the 1st day of

December, 1924.
Article III.—This Order may be cited as "The Heavy Motor Car (Northern Ireland) (Amendment) Order, 1924."

## THE LABOURERS (NORTHERN IRELAND) ORDER, 1924.

The Ministry of Home Affairs for Northern Ireland, in pursuance of the provisions of the Labourers Acts (Northern Ireland), 1883 to 1923, and in exercise of the powers vested in the Ministry in this behalf, after consultation with the President of the Incorporated Law Society of Northern Ireland, hereby orders and directs that the following shall be rules under the said Acts and shall, from and after the date hereof, have effect and be observed in regard to the several matters to which they relate :

1. This Order may be cited as "The Labourers (Northern Ireland) Order, 1924," and shall be construed as one with the Labourers (Ireland) Order, 1912. 2. Rule 47 of the Labourers (Ireland) Order,

1912, is hereby revoked, and the said Order shall henceforth be read and construed as if the following rule numbered 47 were therein inserted in place of and substitution for Rule 47 hereby revoked.

47. The scale of payment for shorthand writers employed at Local Inquiries shall be as follows:-

8d. for every 72 words in the transcript of the notes taken, which transcript shall be typewritten or printed.

An allowance of £1 ls. 0d. for each day or part of a day engaged in notetaking.

Numbers shall be prefixed to the questions in the transcript without charge, but for providing an Index or Table of Contents thereto the following fees may be allowed:-

5/- for not less than 50 pages of transcript. 100

7/6d. 10/-150 300 15/-

Second class railway fare and car hire, where necessary, shall be allowed to the person employed as from the nearest place where the services of a suitable and competent shorthand writer might have been obtained.

COMPANIES (RECONSTITUTION OF RECORDS) ACT (NORTHERN IRELAND), 1923.

Notice to Secretaries of Companies, Solicitors, Accountants and all who may be concerned.

NOTICE is hereby given that any Company to which the Companies (Reconstitution of Records) Act (Northern Ireland), 1923, applies which fails to comply with the requirements of that Act not later than 31st March, 1925, shall ipso facto be dissolved from and after that date, pursuant to the provisions of Section 5 (3) of the Act.

The Act requires each Company not dissolved struck off the register or wound up before 26th May, 1921, whose records were destroyed in the Custom House, Dublin (and all but three were so destroyed), and whose registered office was situate in Northern Ireland at 1st January, 1922, to furnish to the Registrar of Joint Stock Companies for Northern Ireland a statement in the form prescribed by the Act, together with copies of its Memorandum and Articles of Association and other documents containing any record with respect to the constitution, objects and powers of the Company.

Requisitions for compliance and reminders have been issued to all Companies which can be identified as belonging to Northern Ireland, the great majority of which have already complied, and this notice is issued as a reminder to such Companies as have not yet responded, and also as a notice to such Companies as may not have been aware of the obligation laid upon them and of the penalty of dissolution for noncompliance.

LIVE STOCK BREEDING ACT (NORTH-ERN IRELAND), 1922.

LIVE STOCK BREEDING (NORTHERN IRELAND) RULES, 1924.

Dated the twenty-third day of September, 1924
The Ministry of Agriculture by virtue and in
exercise of the power for this purpose vested
in it by the Live Stock Breeding Act (Northern Ireland), 1922, and of every other power
in that behalf enabling it, hereby makes the
rules following, that is to say:—

### 1. Short Title.

1. These Rules may be cited as the Live Stock Breeding (Northern Ireland) Rules, 1924.

# II. Definitions.

2. In these Rules unless the context shall require a different construction:—

(1) The expression "Act" shall mean the Live Stock Breeding (Northern Ireland)

(2) The expression "the Ministry" shall mean the Ministry of Agriculture Northern Ireland.

(3) The expression "owner" shall have the same meaning as in the Act.

(4) Words in the singular shall include the plural, and words in the plural shall include the singular.

(5) The expression "bull" shall mean any uncastrated male of the bovine species of the prescribed age

the prescribed age.

(6) The expression "writing" shall include print and writing or print produced by any mechanical of chemical process.

(7) The expression "certified" means cer-

(7) The expression "certified" means certified by the Registrar of Licences or other duly authorised officer of the Ministry.

# III. Prescribed Age of Bulls.

3. For the purposes of the Act and these Rules bulls born in the months of January and February in any year shall be deemed to be of the prescribed age on the 30th September in that year; bulls born in March, April, May, June, July and August in any year shall be deemed to be of the prescribed age on the 31st March in the year next following the date of birth; bulls born in September, October, November or December shall be deemed to be of the prescribed age on the 30th September in the year next following date of birth. Provided that all bulls born on or before the 28th February, 1923, shall be deemed to have attained the prescribed age on the 1st January, 1924.

# IV. Application for Licence.

4. An application for a licence to keep a bull shall be made in the form or to the effect stated at (A) in the schedule to these Rules and shall be lodged with the Ministry not later than the 1st day of November in any year in the case of bulls born in March, April, May, June, July and August of the preceding year, and not later than the 1st day of August in any year in the case of bulls born in the months of January and February of that year,

or in the months of September, October, November and December of the preceding year.

#### V. Conditions as to Inspection and Examination.

5. The Ministry shall notify in such manner as it thinks fit the names of the places and dates at which bulls will be inspected and examined for licences, and the owners shall provide all reasonable facilities for the inspection and examination of their bulls at the said places provided that a bull that has previously been inspected for any other purpose on behalf of the Ministry may with the consent of the Ministry be exempted from the inspection and examination prescribed by this Rule.

# VI. Notices and Services thereof.

6. (1) Any notice required or authorized by

these Rules shall be in writing.

(2) Any notice required or authorized by these Rules to be served shall be deemed to be sufficiently served if it is sent by post addressed to the person to be served at his last known place of abode or business, and service shall be deemed to be made at the time at which the notice would in the ordinary course of post be delivered.

#### VII. Form of Licence.

7. A licence to keep a bull shall be in the form or to the effect stated at (B) in the schedule to these Rules.

# VIII. Fee for Licence and Certified Copy thereof.

8. The fee payable for a licence to keep a bull shall be five shillings, and one certified copy of the licence may be obtained by the owner of the bull without further charge.

# IX. Permit to keep an Unlicensed Bull for Fattening.

9. The owner of a bull intended to be fattened off for slaughter shall make application for such a permit in the form or to the effect stated at (C) in the schedule to these Rules, and shall, if required, present such bull for inspection at such place and at such time as may be specified in any notice issued by the Ministry.

## X. Fee for Permit.

10. The fee payable for a permit to keep an unlicenced bull to be fattened off for slaughter shall be one shilling.

### XI. Marking of Bulls.

11. In cases where the Ministry decides to mark bulls the mark shall consist of a right hand or such other mark as may be registered by the Ministry, and shall be tattooed on the right ear or other appropriate place. The said mark may be used in conjunction with a letter or numbers or both.

# XII. Appeals.

12. Where the Ministry refuses to grant or transfer a licence in respect of any bull or suspends or revokes any licence, or requires the slaughtering or castration of any bull the owner of the bull may within a period of fourten days from the date of service on him of notice of such refusal, suspension or revocation, or of order to slaughter or castrate, and on payment to the Ministry of a fee of £2 2s

lodge an appeal in the form or to the effect stated at (D) in the schedule to these Rules gaainst such refusal, revocation, suspension or order, with the object of having the bull inspected and examined by such member or members of the Panel of Referees appointed under the Act by the Governor of Northern Ireland as may be selected by the Ministry.

The fee payable on an application under this Rule shall, if the Ministry does not confirm the decision to which the application relates, be returned to the applicant by the Ministry.

## XIII. Change of Ownership, Death or Castration of Bull.

13. Notice of any sale or hiring or other change in the ownership or control of a bull in respect of which a licence or a permit is in force or of its castration or death shall be given by the owner to the Misistry within seven days of such sale, hiring or change of ownership or control. Such notice shall be in the form or to the effect stated at (E) in the schedule to these Rules, and shall be delivered at or forwarded by post to the Ministry's Head Office in Belfast.

#### XIV. Surrender of Licence or Permit.

14. The owner of a bull in respect of which a licence or permit was issued shall, in the event of the licence or permit having expired or being revoked, suspended or cancelled return such licence (together with the certified copy, if any) or permit to the Ministry within seven days from the date of expiry thereof, or within seven days from the date of service on him of notice of revocation, suspension or cancellation of such licence or permit.

#### XV. Revocation of Previous Rules.

- 15. The Live Stock Breeding (Northern Ireland) Rules, 1923 (Statutory Rules and Orders of Northern Ireland, Numbers 26 and 59, of 1923) are hereby revoked as from this date, but such revocation shall not:—
  - (I) affect the previous operation of those Rules or anything duly done or suffered thereunder; or
  - (II) affect any right, privilege, obligation, or liability acquired, accrued or incurred thereunder; or
  - (III) affect any penalty incurred in respect of any offence committed against those Rules; or
  - (IV) affect any investigation, legal proceeding or remedy in respect of any such right, privilege, obligation, liability or penalty as aforesaid; and any such investigation, legal proceeding or remedy may be instituted, continued or enforced, and any such penalty may be imposed, as if these Rules had not been made.

# XVI. General.

16. The Ministry may from time to time rescind, amend or vary these Rules or any of them as occasion may require.
