CIVIL AUTHORITIES (SPECIAL POWERS) ACTS (NORTHERN IRELAND), 1922-1943

Regulations dated 16th day of June, 1954, made by the Minister of Home Affairs under sub-section (3) of section one of the Civil Authorities (Special Powers) Act (Northern Ireland), 1922.

Whereas by virtue of the Civil Authorities (Special Powers) Act (Northern Ireland), 1922, there are in force certain Regulations for peace and order in Northern Ireland being:

- (a) Regulations contained in the Schedule to that Act; and
- (b) Regulations made by the Minister of Home Affairs for Northern Ireland pursuant to powers conferred by sub-section (3) of section one of the said Act

(which regulations where contained in the Schedule or made as aforesaid are hereinafter referred to as the "principal Regulations"):

And whereas the said Minister is empowered by the said sub-section (3) to make Regulations for making further provision for the preservation of the peace and maintenance of order and any Regulations so made shall, subject to the provision: of the said Act, have effect and be in force in like manner as Regulations contained in the Schedule to that Act:

And whereas it is expedient that further provision for the preservation of the peace and maintenance of order should be made:

Now, therefore, I, the Right Honourable George B. Hanna, Q.C., M.P., Minister of Home Affairs for Northern Ireland, in exercise of the powers conferred on me by the said sub-section, do hereby make the following Regulations:

1. At the end of Regulation 3A of the principal Regulations there shall be inserted the following Regulations:

- "4. Any police officer or constable may, if he suspects that any house, building, land, vehicle, vessel, aircraft, or other premises or anything therein are being or have been or are about to be constructed, used or kept for any purpose or in any way prejudicial to the preservation of the peace or maintenance of order, or that a crime or offence against these Regulations is being or has been committed thereon or therein, enter, if need be by force, the house, building, land, vehicle, vessel, aircraft or premises at any time of the day or night and examine, search and inspect the same or any part thereof and may seize anything found thereon or therein or any such vehicle, vessel or aircraft which he suspects is being used or intended to be used for any such purpose as aforesaid or is being kept or used in contravention of these Regulations.
- "5. Any police officer or constable may stop any vehicle travelling along any public road and if he suspects that any vehicle travelling upon any public road is being used for any purpose or in any way prejudicial to the preservation of the peace or maintenance of order or otherwise unlawfully may search and seize the vehicle and seize anything

found therein which he suspects is being used or intended to be used for any such pur-pose or in any such way as aforesaid.

- **"6**. Any police officer or constable, if he suspects that any person is carrying any firearms, ammunition, explosive substances or any article or document for any purpose or in any way prejudicial to the preservation of the peace or maintenance of order, may stop the peace or maintenance or order, may stop that person and search him and may seize any firearms, ammunition, explosive sub-stances or any article or document carried by that person which he suspects is being used or intended to be used for any such purpose or in any way as aforesaid,
- "7. It shall be the duty of any person, if so required by a police officer or constable, to stop and answer to the best of his ability and knowledge any questions which may be reasonably addressed to him and if he refuses or fails to stop or if he refuses or fails so to answer such questions he shall be guilty of an offence against these Regulations."

2. At the end of Regulation 35 of the principal Regulations, there shall be inserted the following Regulation :

"36. The Civil Authority may order anything seized under or by virtue of these Regula-tions to be disposed of in such manner as he may think fit."

RATES OF INTEREST ON GOVERNMENT LOANS

Pursuant to Section 1(7)(a) of the Government Loans Act (Northern Ireland), 1939, the Ministry of Finance hereby gives notice that the under-mentioned rates of interest shall be chargeable on loans or instalments of loans of the following descriptions advanced from the Government Loans Fund, on or after the 21st June, 1954, namely:---

I. LOCAL OR PUBLIC LOANS

- (a) Loans to local authorities as defined in Section 11(2) of the Government Loans Act (Northern Ireland), 1939, being loans secured on local rates:
 - (i) Loans other than those set out in sub
 - paragraph (ii) hereunder: Loans for periods not exceeding 15 years, 34 per cent.
 - Loans for periods exceeding 15 years, but not exceeding 60 years, 34 per cent. (ii) Loans for the repayment of existing loans,*
 - and loans for gas, electricity, transport or other trading undertakings:
 - Loans for periods not exceeding 15 years, $3\frac{3}{2}$ per cent.
 - Loans for periods exceeding 15 years, but not exceeding 25 years, 4 per cent. Loans for periods exceeding 25 years, but not exceeding 50 years, 44 per cent.
- (b) Loans to other public authorities, as defined in paragraph 1 (b) of the First Schedule to the Government Loans Act (Northern Ireland), 1939: Loans for periods not exceeding 25 years, 4 per cent.

*Loans for the repayment of existing loans under paragraph (a) (ii) of Part I of this Notice will be made only in respect of loans obtained otherwise than from the Government Loans Fund, and where the rate of interest on the existing loan exceeds 33 per cent.

II. LAND AND WORKS LOANS

Loans to Civil Servants for the purchase or erection of houses for their accommodation and other Land and Works Loans:

Loans for periods not exceeding 25 years, 4 per cent.

Loans for periods exceeding 25, but not exceeding 35 years. $4\frac{1}{4}$ per cent.

III. EDUCATIONAL DEVELOPMENT LOANS

(a) Loans for the purchase, erection, extension, or alteration of school buildings (not being schools in respect of which local or public loans may be made):

Loans for periods not exceeding 25 years, 4 per cent.

Loans for periods exceeding 25, but not exceeding 50 years, $4\frac{1}{4}$ per cent.

(b) Loans for the equipment of such schools as aforesaid :

> Loans for periods not exceeding 10 years, 4 per cent.

IV. OTHER LOANS

The rates of interest to be charged on loans other than those defined in Parts I, II and III of this Notice will be determined by the Ministry of Finance according to the circumstances of each individual case.

METHOD OF REPAYMENT

Local and Public Loans as defined in Part I of this Local and Public Loans as defined in Part I of this Notice will be repayable as the Ministry of Finance may determine, either (i) by equal half-yearly instal-ments of the principal advanced, together with interest on the balance of principal from time to time outstanding: or (ii) by equal half-yearly instalments of annuities calculated to include interest at the rates specified.

Loans defined in Parts II and III of this Notice will normally be repayable by equal half-yearly instalments of annuities calculated to include interest at the rates specified.

Other loans will be repayable by such methods as the Ministry of Finance may determine according to the circumstances.

MINUTE DETERMINING THE CONDITIONS UPON WHICH (I) GOVERNMENT LOANS MAY BE REDEEMED BEFORE THEIR DUE DATES OF REPAYMENT; AND (II) A REDUCTION IN THE RATE OF INTEREST APPLICABLE TO GOVERNMENT LOANS MAY BE EFFECTED

The Ministry of Finance has had under further Ι. consideration the terms upon which repayment of loans made from the Government Loans Fund to Local Authorities and other borrowers can be accepted in advance of the date at which in accord-ance with the terms agreed to by the borrower at the time when the loan was made, the principal of such loans falls due for repayment.

Having regard to the intention of Parliament, as embodied in the Statutes governing the Fund, that the Fund should be safeguarded as far as possible against loss, and to the importance of maintaining the general principles that borrowers repaying in advance of the due date should repay an amount sufficient to liquidate the liability incurred by the Fund in respect of the advance and to provide against Fund in respect of the advance and to provide against loss on the re-issue from the Fund of the principal of loans so repaid, the Ministry of Finance hereby determines as follows:

Repayment in advance of the due date of loans made from the Government Loans Fund at rates of interest exceeding 3³/₄ per cent. per annum, shall be effected by the transfer to the Fund of an amount of cash representing the present value of the future annuity payments (or payments of equal instalments of principal with diminishing interest) still remaining to be made to the Government Loans Fund under the terms agreed to by the borrower at the time when the loan was made, such present value being calculated by discounting the half-yearly instalments of annuity (or other half-yearly payments) at a rate of one and seven-eights per cent. per half-year.

Provided always that the Ministry may accept (subject to due notice being received) repayment of principal at any time on the basis of £100 cash for each £100 principal outstanding, in the following cases, namely:

- (1) The outstanding balance of loans issued at rates not in excess of 3³/₃ per cent. per annum.
- (2) Unexpended balances of loans already advanced, where the Ministry is satisfied that the balance is unexpended either because the scheme for which the loan was issued was less costly than was anticipated, or because it has been definitely reduced in extent, and also that application for repayment of the amount to the Government Loans Fund is made within five years from the date of its issue therefrom.
- (3) Loans issued to individuals and subject to repay-ment over a period of not more than 35 years.
- (4) Loans issued under the Glebe Loans (Ireland) Acts.

II. The Ministry of Finance hereby determines that a reduction in the rate of interest applicable to any loan advanced from the Government Loans Fund may be effected by the transfer to the Fund of:

an amount of premium representing the difference between the present value of the future annuity payments (or payments of equal instalments of principal with diminishing interest still remaining to be made to the Government Loans Fund under the terms agreed to by the borrower at the time when the loan was made (such present value being calculated by discounting the half-yearly instalments of annuity, or other half-yearly payments, at a rate of one and seven-eighths per cent. per half-year), and the present value of the proposed future half-yearly instalments (cal-culated at the reduced rate of interest proposed) also discounted at a rate of one and seven-eighths per cent, per half-year.

All other Minutes on the subjects of I and II are hereby revoked.
