INTOXICATING LIQUOR

Compensation: Charges in respect of Licences Order, dated 15th June, 1955, made by the Ministry of Finance under Section 3 of the Intoxicating Liquor Act (Northern Ireland), 1923, as amended by the Intoxicating Liquor (Finance) Act (Northern Ireland), 1925.

In pursuance of sub-Sections (3)(b) and (4) of section three of the Intoxicating Liquor Act (Northern Ireland), 1923, as amended by the Intoxicating Liquor (Finance) Act (Northern Ireland), 1925, the Ministry of Finance hereby prescribes that the rates at which charges are to be levied in respect of all licences for the sale of intoxicating liquor by retail granted or renewed during the year ending the 30th day of September, 1956, shall be fourteen shillings and tenpence for each pound sterling of the maximum rates of charge authorised by sub-section (1) of section one of the Intoxicating Liquor (Finance) Act (Northern Ireland), 1925. This Order may be cited as the Intoxicating Liquor (Compensation Charges) Order (Northern Ireland), 1955.

(This note is not part of the Order, but is intended to indicate its general purport).

The Order prescribes the rates at which charges are to be imposed in respect of licences for the sale of intoxicating liquor by retail to be granted or renewed during the year ending 30th September, 1956.

This Order increases the weight limit for such exempt importations from 8 ozs. to 2½ lbs., and also extends the exemption, with similar limitations, to importations through non-postal channels. These extensions are in accordance with Article IV of the International Convention to Facilitate the Importation of Commercial the Importation of Commercial Samples and Advertising Material (Cmd. 9054).
