COUNTY COURTS—ARMAGH

Order in Council, dated 13th February, 1956, made under section one of the Court Houses (Ireland) Act, 1840, section thirty-one of the Civil Bill Courts (Ireland) Act, 1851, section four of the Chairman of Quarter Sessions (Ireland) Juristical Chairman of Courts (Ireland) Sessions (Ireland) diction Act, 1876, and section ninety-one of the County Officers and Courts (Ireland) Act, 1877.

- I, John De Vere, Baron Wakehurst, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, by and with the advice of the Privy Council of Northern Ireland, advice of the Privy Council of Northern Ireland, in exercise of the powers conferred on me by section one of the Court Houses (Ireland) Act, 1840, section thirty-one of the Civil Bill Courts (Ireland) Act, 1851, section four of the Chairman of Quarter Sessions (Ireland) Jurisdiction Act, 1876, and section ninety-one of the County Officers and Courts (Ireland) Act, 1877, and of all other powers me thereunto enabling, do hereby order and direct as follows:
- 1. For the purpose of the conduct of the criminal business of the quarter sessions of the peace (other than appeals from petty sessions) for the several divisions of the county of Armagh as constituted at the commencement of this Order:—
 - (1) those divisions shall be merged in the county
 - there shall be held in each year four sittings in the city of Armagh.
- 2. For the purpose of the conduct of all such other business as may be properly cognizable or determinable at any general or quarter sessions of the peace or county court for the said county of Armagh there shall be held in each year:
 - for the division of Armagh, four courts in the city of Armagh;
- for the division of Lurgan:
 (a) four courts in the borough of Lurgan,

- (b) a court at the Hilary and Trinity sessions in the borough of Portadown;
- (3) for the division of Markethill, four courts in the town of Newry in the county of Down (being distant not more than six miles from the common boundary of the counties of Armagh and Down).

Provided that the business to be transacted at the Courts held in the borough of Portadown shall consist of the hearing only of causes commenced by ordinary, default or ejectment civil bills.

3. Except in so far as they constitute and define the several divisions hereinbefore referred to, the following instruments relating to the conduct of the business of the general and quarter sessions of the peace and county court for the said county of Armagh are hereby revoked, that is to say:—

The Proclamation in Council dated respectively the thirteenth day of December, eighteen hundred and thirty-nine, and the second day of January, eighteen hundred and forty-one;

The Orders in Council and Proclamations dated respectively the fourth day of October, eighteen hundred and seventy-six, the twentieth day of October, eighteen hundred and seventy-nine, and the sixth day of July, and the twenty-third day of October, eighteen hundred and ninety-seven.

The Orders in Council dated respectively the twentieth day of December, nineteen hundred and forty, and the tenth day of March, nine-teen hundred and forty-seven.

This Order may be cited as the County Court Sittings (Armagh) Order (Northern Ireland), 1956, and shall come into force on the first day of February, nineteen hundred and fifty-six.

DANGEROUS DRUGS ACT, 1951

DANGEROUS DRUGS REGULATIONS, 1938 SUSPENSION OF WITHDRAWAL OF AUTHORITY OF MRS. MURIEL STUART ALFORD (NEE McCLAY),

M.R.C.V.S.

WHEREAS in pursuance of the powers conferred on the Minister of Home Affairs by the Dangerous Drugs Regulations, 1938, the Authority granted by the said Regulations to registered veterinary surgeons to be in possession of and to supply the drugs or preparations to which these Regulations apply was, by Notice published in the Belfast Gazette on the 22nd October, 1954, withdrawn from Muriel Stuart Alford, M.R.C.V.S., of 490 Antrim Road, Belfast.

And whereas at the same time a direction was given by the Minister of Home Affairs that it should not be lawful for the said Muriel Stuart Alford to give prescriptions for the purposes of the said Regulations:

Now, therefore, I, the Right Honourable George B. Hanna, Q.C., Minister of Home Affairs for Northern Ireland, do hereby suspend, until further order, the operation of the said notice of withdrawal and of the said direction regarding prescriptions.
