WHEREAS it is enacted by section seventeen of the Finance Act, 1924, that, subject to the provisions of that section, a game certificate or a gun licence taken out in Northern Ireland shall, without further payment of duty be available in Great Britain:

And Whereas by the said Act it is further enacted that the said section seventeen shall come into operation on the date which is declared by His Majesty in Council to be the date as on which by virtue of legislation passed by the Parliament of Northern Ireland a corresponding concession with respect to the availability in Northern Ireland of game licences and gun licences taken out in Great Britain comes into operation:

And Whereas by section six of the Finance (Northern Ireland) Act, 1924, it is provided that, subject to the provisions of that section a game licence or a gun licence taken out in Great Britain shall without further payment

of duty, be available in Northern Ireland:

And Whereas by the said last-mentioned Act it is further enacted that the said section six shall come into operation on the first day of

January, nineteen hundred and twenty-five: Now, Therefore, His Majesty, by and with the advice of His Privy Council, is pleased to declare, and it is hereby declared, that the first day of January, nineteen hundred and twenty-five, is for the purposes of section seventeen of the Finance Act, 1924, the date as on which by virtue of legislation passed by the Parliament of Northern Ireland a corresponding concession with respect to the availability in Northern Ireland of game licences and gun licences taken out in Great Britain comes into operation.

THE HOUSING ACTS AMENDMENT ACT (NORTHERN IRELAND), 1924.

RURAL DISTRICT OF NEWTOWNARDS.

WHEREAS the Ministry of Home Affairs for Northern Ireland (hereinafter referred to as "the Ministry") is satisfied that there is an urgent need for houses in the area including the industrial centre of Comber, situate in the Rural District of Newtownards in the Administrative County of Down, and that proper housing accommodation for the working classes cannot be secured in such area except by the making of grants under the provisions of Section 1 of the Housing Act (Northern Ireland), 1923, as amended by Section 2 of the Housing Acts Amendment Act (Northern Ireland), 1924, in respect of houses erected in

And whereas the said area is defined in the Schedule to this Order and is not within one mile and a half from the boundary of the area of a local authority within the meaning of Section 6 of the Housing Act (Northern

Ireland), 1923:

Now therefore the Ministry, in exercise of the powers vested in it by Sub-section 8 of Section 1 of the Housing Act (Northern Ireland), 1923, as amended by Section 2 of the Housing Acts Amendment Act (Northern Ireland), 1924, and after consultation with the Ministry of Finance for Northern Ireland, by this Order, hereby extends, subject to the proviso (b) contained in the said Sub-section 8, the provisions of Sub-sections (1) to (7) inclusive of Section 1 of the Housing Act (Northern Ireland), 1923, as amended by Section 2 of the Housing Acts Amendment Act (Northern Ireland), 1924, to the erection of houses in the area defined in the Schedule to this Order.

And the Ministry hereby determines that the grant payable in respect of each house so constructed shall be at the rate of sixty pounds.

SCHEDULE ABOVE REFERRED TO.

The area comprised within a radius of one statute mile as measured in a straight line on a six-inch Ordnance Sheet from the centre of the Railway Bridge in High Street in the Town of Comber, and situate in the Rural District of Newtownards and County of Down.

CONSTABULARY ACT (NORTHERN IRELAND), 1922.

THE COLORADO BEETLE (NORTHERN IRELAND) ORDER OF 1924.

(Dated 31st December, 1924). (D.I.P. 10).

The Ministry of Agriculture for Northern Ireland by virtue and in exercise of the powers vested in it under the Destructive Insects and Pests Acts, 1877 and 1907, and of every other power enabling it in that behalf, orders, and it is hereby ordered as follows:-

Prohibition of Importation of Potatoes.

1. For the prevention of the introduction of the Colorado Beetle the landing in Northern Ireland of any potatoes grown in the United States of America is hereby prohibited.

Commencement.

2. This Order shall take immediate effect provided that this Order shall not be deemed to prevent the landing of potatoes shipped from the United States of America before the date of this Order.

Short Title.

This Order may be cited as the COLORADO BEETLE (NORTHERN IRELAND) ORDER of 1924.

NATIONAL DEBT.

GOVERNMENT STOCK (REDEMPTION). REGULATIONS.

The Treasury, in pursuance of the powers conferred upon them by the Third Schedule to the Finance Act, 1921, and of all other powers enabling them in that behalf, hereby make the following Regulations:

1.—(1) These Regulations may be cited as the Government Stock (Redemption) Regula-

tions, 1924.

(2) In these Regulations the expression "person of unsound mind" includes a person who through mental infirmity arising from disease or age is incapable of managing his affairs, and the expression "committee" includes a quasi-committee.

(3) The Interpretation Act, 1889, applies for the purpose of the interpretation of these Regulations as it applies for the purpose of the interpretation of an Act of Parliament.

- 2.-(1) Where any principal moneys become payable on the redemption of any Government stock standing in the name of a stockholder who is a person of unsound mind, or an infant, or a person otherwise under disability, the committee, the guardian, or the person having power in law to administer the property of the stockholder may by notice in writing give to the Bank on behalf of the stockholder directions for the reinvestment of those moneys in such Government stock as may be specified in the
- (2) Where any directions for reinvestment are given under this Regulation, the Bank shall cause any Government stock purchased in pursuance of the directions to be transferred into the name or names in which the redeemed stock was standing in the Books of the Bank at the date of redemption.
- 3. Any order or decree of any court in Great Britain or Northern Ireland whereby the right to receive any principal moneys which become payable on the redemption of any Government stock standing in the name of any stockholder (whether as sole stockholder or jointly with any other person) who is a person of unsound mind, or an infant, or a person otherwise under disability, is vested in any person as committee or guardian of the stockholder or otherwise, shall be sufficient authority to the Bank to pay the principal moneys to that person in accordance with the order or decree.

4. Nothing in these Regulations shall be taken to prejudice the right of the Bank to require evidence to be given to their satisfaction to prove that any person purporting to give directions under these Regulations is a person having power thereunder to give directions, or that a person claiming to be paid any moneys under these Regulations is a person to whom the payment may properly be made thereunder; and with respect to matters inci-

dental to such proof.

5.—(1) An official extract of any such appointment as is mentioned in Section 13 of the Judicial Factors (Scotland) Act, 1889, shall, in any case where any Government stock is specified in the extract, or in a certificate under seal by the accountant of court produced together with the extract, as belonging to or forming part of the estate under the charge of the person named in the extract, be deemed for the purpose of these Regulations to be a decree whereby the right to receive the princi-

pal moneys becoming payable on the redemption of that stock is vested in the person so named.

(2) In the application of these Regulations to Scotland the expression "infant" includes pupil or minor and the expression "guardian" includes tutor or curator.
