LINEN AND COTTON HANDKERCHIEF AND HOUSEHOLD GOODS AND LINEN PIECE GOODS WAGES COUNCIL (NORTHERN IRELAND)

The Linen and Cotton Handkerchief and Household Goods and Linen Piece Goods Wages Council (Northern Ireland) hereby gives notice of its intention to submit to the Ministry of Labour and National Insurance proposals for the amendment of the Linen and Cotton Handkerchief and Household Goods and Linen Piece Goods Wages Council (Northern Ire-land) Wages Regulation Order, 1956 (Order N.I.H.H.G. (141)) (S.R. & O. (N.I.) 1956, No. 57) relating to statutory minimum remuneration.

The Wages Council will consider any written representations with respect to the above-mentioned proposals which may be sent to it within twenty-one days from 9th November, 1956.
