TRUNK ROAD IMPROVEMENT AT MARTRAY

The Ministry of Commerce hereby gives notice that it proposes to construct a portion of new road in

substitution for a corresponding portion of the existing Belfast-Ballygawley-Londonderry Trunk Road in the townland of Martray, Co. Tyrone. In accordance with the provisions of the First Schedule to the Roads Act (Northern Ireland), 1948, the Ministry also gives notice that it proposes to make an Order under Section 1 of the Act, the general effect of which will be as follows:—

- The portion of new road, which will be constructed between points on the trunk road approximately 720 yards and 140 yards respectively south-west of the junction of the trunk road and the unclassified road D.R. 314, will become part of the Belfast-Ballygawley-Londonderry Trunk Road on the date of coming into force of the Order.
- That portion of the existing Trunk Road which lies between the aforementioned points will cease to be part of the Belfast-Ballygawley-Londonderry Trunk Road on the first day of April next after the new portion of Trunk Road is opened for the purposes of through traffic.
