1957. No. 94

#### GAME

Order, dated 28th May, 1957, made by the Minister of Home Affairs under Sections Seven C and Seven F of the Game Preservation Act (Northern Ireland), 1928, as inserted by Section three of the Game Law Amendment Act (Northern Ireland),

WHEREAS it is provided by sub-section (1) of section seven C of the Game Preservation Act (Northern Ireland), 1928, (hereinafter referred to as the "principal Act") as inserted by section three of the Game Law Amendment Act (Northern Ireland), 1951, that where the Minister of Home Affairs is satisfied that it is necessary or expedient to provide special protection for any kind of game, he may by Order prohibit the killing or taking, or the sale or purchase of game of any kind prescribed by the Order, during such period not exceeding one year as shall be so prescribed.

And whereas in accordance with the provisions of sub-section (5) of section seven F of the principal Act notice of the proposal to make an Order and the purport thereof was duly given on the 29th day of April, 1957:

And whereas no objections to the making of the Order have been received.

Now, therefore, I, the Right Honourable W. W. B. Topping, Q.C., Minister of Home Affairs for Northern Ireland, in pursuance of the powers vested in me by sections seven C and seven F of the principal Act as inserted by section three of the Game Law Amendment Act (Northern Ireland), 1951, hereby Order and Direct as follows, that is to say:-

- 1. It shall not be lawful for any person to sell or purchase partridge and hen pheasants for consumption in Northern Ireland or elsewhere by human beings or animals, at any time during the operation of this Order.
- This Order may be cited as the Game Preservation (Sale or Purchase of Partridge and Hen Pheasants for Consumption) Order (Northern Ireland), 1957, and shall remain in force for a period of one year from the 1st June, 1957, unless sooner
