WILD BIRDS : BIRD SANCTUARY

Order, dated 27th May, 1959, made by the Minister of Home Affairs under section ten of the Wild Birds Protection Act (Northern Ireland), 1931.

WHEREAS by Section ten of the Wild Birds Protection Act (Northern Ireland), 1931, (a) (hereinafter referred to as the Act), it is provided that with a view to the creation of a bird sanctuary the Minister of Home Affairs may by Order direct that in any district defined by the Order all birds with or without any specified exceptions shall in that district be deemed to be classified in Category 1, and on the making of any such Order the Act shall in that district have effect accordingly.

And where as representations have been made to me that such an Order should be made in respect of the district described in the Schedule :

And whereas the owners and occupiers of the lands comprised in the said district consent to the Order being made :

And whereas notice of intention to make such an Order and the purport thereof was duly given on the ninth day of March, 1959, in accordance with the provisions of sub-section (6) of section sixteen of the Act :

And whereas no objections to the making of the Order were received :

Now, therefore, I, the Right Honourable W. W. B. Topping, Q.C., Minister of Home Affairs, in exercise of the powers conferred on me by section ten of the Act hereby order and direct as follows :—

1. In the district defined in the Schedule to this Order, all birds, with the exception of hooded crows, magpies and woodpigeons, shall be deemed to be classified in Category 1.

2. This Order may be cited as the Wild Birds Protection (Timpany Estate Bird Sanctuary) (Northern Ireland) Order, 1959.

NOTE 1.

This is a booking charge in respect of an application for a call to a specified name and address for the specified purpose of communication with any telephone number at that address (not being a call of the kind mentioned in column 3 or 5).

NOTE 2.

This is a booking charge in respect of an application for a call to a specified telephone number or to a specified name and address (or to one of two specified alternative numbers or addresses) for the specified purpose of communicating with a particular person (or one of two alternative persons) identified by name or by such description as the Postmaster General may consider sufficient or for connection to a particular department, correspondence reference, code number or extension number.

NOTE 3.

This is a charge in respect of a request to the

Postmaster General to obtain, by means of a telephone call to a country, information as to :

- the telephone number of any person (identified in such manner as the Postmaster General may consider sufficient) in that country, or
- the name and address of the person in whose name a telephone installation specified by number is rented or otherwise held in that country.

This charge is not payable if, when the request is made, a call is booked to the telephone number and the call is connected.

NOTE 4.

This charge is not payable where a booking charge for a personal call is due.

NOTE 5.

Except as otherwise stated in the Schedule, the charges specified therein are payable by virtue of the Telephone Regulations, 1957, for or in respect of the call or the application therefor.

The Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made Regulations under Sections 1 and 5 of the Income Tax (Repayment of Post-War Credits) Act, 1959, viz:—

The Post-War Credit (Income Tax) Regulations, 1959.

These Regulations prescribe the qualifications to receive repayment of Post-War Credits.

The classes who qualify are set out in Regulation 3 and are:—

- (1) Age: men aged 63 or over and women aged 58 or over;
- (2) Death: the personal representatives or beneficiaries of Credit holders who have died;
- (3) Hardship:
 - (a) persons who for a continuous period of 12 weeks ending after 7th April, 1959, have been receiving National Assistance;
 - (b) persons who, after 7th April, 1959, are persons named in a register of blind persons required under statute to be kept by a local authority;
 - (c) persons who, after 7th April, 1959, are receiving constant attendance allowance or unemployability supplement under the War Pensions Instruments, the Industrial Injuries Acts, or the Industrial Diseases (Benefit) Acts, or who would have been in receipt of unemployability supplement if they had not claimed an alternative benefit, or would have been in receipt

of constant attendance allowance but for being a hospital in-patient.

In the hardship cases the responsible authority, as defined in Regulations 2(3), will certify the facts on which the claim is based.

Regulation 5 provides that the trustee in bankruptcy may claim repayment of a Credit when the bankrupt would have been qualified to receive repayment had he not become bankrupt. This preserves the law which has been in force since 1954.

Regulation 6 lays down certain requirements for verifying applications for repayments of Credits.

The Regulations come into operation on the 1st June, 1959, and have been published as Statutory Instruments, 1959, No. 876.

QUEEN'S BENCH DIVISION.—IN BANKRUPTCY
