#### STAMP DUTIES.

WHEREAS Section 12 (2) of the Finance Act, 1899, provides inter alia that his Majesty's Commissioners of Inland Revenue may substitute, as respects any foreign or colonial currency mentioned in the Schedule to that Act, any rate of exchange for that specified in the Schedule and may add to the Schedule a rate of exchange for any foreign or colonial currency not mentioned therein, and that such Act shall be construed as if any rate of exchange for the time being substituted or added were contained in the said Schedule, and in the case of the substitution of a rate of exchange as if the rate for which the new rate is substituted were omitted from that Schedule. And whereas by notices duly advertised pursuant to the said Section in the month of August, 1920, the said Commissioners substituted certain rates of exchange for those specified in the said Schedule. And whereas under the Government of Ireland Act, 1920, and the Orders in Council made pursuant thereto, the powers of the Commissioners of Inland Revenue in relation to taxes which the Parliament of Northern Ireland have power to impose are transferred to the Ministry of Finance for And whereas by notices Northern Ireland. duly advertised pursuant to the said Section in the months of July and August, 1923, and April, 1924, the said Ministry substituted certain rates of exchange for those specified in the said Schedule. Now the said Ministry hereby gives notice that they substitute the following rate of exchange for that specified in the Schedule to the Finance Act, 1899, as varied by the above-mentioned notices now in force under the said Act.

1925. No. LOCOMOTIVE. PETROLEUM.

Regulation dated April 3rd, 1925, made by the Ministry of Home Affairs for Northern Ireland under Section 5 of the Locomotives on Highways Act, 1896 (59 & 60 Vict., c. 36).

The Ministry of Home Affairs for Northern Ireland in exercise of the powers vested in it by Section 5 of the Locomotives on Highways Act, 1896, as adapted under the Government of Ireland Act, 1920, and of all other powers in this behalf enabling the Ministry hereby makes the following Regulations:—

Notwithstanding anything in No. 10 of the Regulations dated 31st July, 1907 (S.R. & O., 1907, No. 614), petroleum spirit may be kept for the purposes of light locomotives in iron or steel drums or barrels of a capacity not exceeding 50 gallons, provided the following conditions are observed:—

(a) The storehouse must be situated at a distance of at least 20 feet from any other building or any highway or public footpath.

(b) Provision must be made by excavation or by the erection of retaining walls to prevent outflow of the spirit in the event of fire if such outflow would be likely to endanger life or cause damage to the property of others.

(c) Notice shall be given to the Local Authority, and the duly authorized officer of such Authority shall be allowed to inspect the spirit in the same manner as is provided in No. 7 of the said Regulations.

This Regulation shall come into force on 1st May, 1925, and may be revoked at any time by the said Ministry of Home Affairs.

THE ILLEGITIMATE CHILDREN (AFFI-LIATION ORDERS) ACT (NORTHERN IRELAND), 1924.

WHEREAS by Section 7 (1) of the Illegitimate Children (Affiliation Orders) Act (Northern Ireland), 1924, it is enacted that an appeal shall lie to the court of quarter sessions, against any order (other than an order for the adjournment of a hearing) made by a court of summary jurisdiction under the said Act, and also against any refusal by such court to make such an order, in like manner as an appeal lies in cases of a civil nature to which the provisions of Section Twenty-four of the Petty Sessions (Ireland) Act, 1851, apply:

And whereas by Section 10 (2) of the Illegi-

And whereas by Section 10 (2) of the Illegitimate Children (Affiliation Orders) Act (Northern Ireland), 1924, the Ministry of Home Affairs for Northern Ireland (except in relation to rules for prescribing forms of Affidavit and any other forms required to be used for the purpose of summary proceedings and appeal proceedings under said Act and for dealing with costs fees and expenses in connec-

tion with such proceedings) is empowered to make such rules as appear to that Ministry to be necessary or proper for the purpose of giving full effect to the said Act, including rules for adapting any provisions of the Summary Jurisdiction (Ireland) Acts in such manner as may be necessary for that purpose:

And whereas by Section 24 of the Petty Sessions (Ireland) Act, 1851, it is *inter alia* enacted that the amount of the recognisance to be entered into by a person prosecuting an appeal shall be double the amount of the sum

and costs ordered to be paid:

And whereas it appears to the said Ministry to be necessary and proper for the purpose of giving full effect to the Illegitimate Children (Affiliation Orders) Act (Northern Ireland), 1924, to make a rule for adapting the said hereinbefore recited provision contained in said Section 24 of the Petty Sessions (Ireland) Act, 1851:

Now therefore, the Ministry of Home Affairs for Northern Ireland in exercise of the powers vested in it by the aforesaid Illegitimate Children (Affiliation Orders) Act (Northern Ireland), 1924, and of all other powers in this behalf enabling the Ministry doth hereby make

the following rule:-

In the application of Section 24 of the Petty Sessions (Ireland) Act, 1851, to an appeal against an Order made under the Illegitimate Children (Affiliation Orders) Act (Northern Ireland), 1924, the words "the sum of £20" shall be substituted for the words "double the amount of the sum and costs ordered to be paid," and the said Section shall be construed and read accordingly.

THE HOUSING ACT (NORTHERN IRE-LAND), 1923.

THE HOUSING ACTS AMENDMENT ACT (NORTHERN IRELAND), 1924.
RURAL DISTRICT OF MAGHERAFELT.

WHEREAS the Ministry of Home Affairs for Northern Ireland (hereinafter referred to as "the Ministry") is satisfied that there is an urgent need for houses in the area including the industrial centre of Upperland, situate in the Rural District of Magherafelt, in the Administrative County of Londonderry, and that proper housing accommodation for the working classes cannot be secured in such area except by the making of grants under the provisions of Section 1 of the Housing Act (Northern Ireland), 1923, as amended by Section 2 of the Housing Acts Amendment Act (Northern Ireland), 1924, in respect of houses erected in the said area:

And whereas the said area is defined in the Schedule to this Order, and is not within one mile and a half from the boundary of the area of a local authority within the meaning of Section 6 of the Housing Act (Northern Ireland), 1923:

Now therefore, the Ministry, in exercise of the powers vested in it by Sub-section 8 of Section 1 of the Housing Act (Northern Ireland), 1923, as amended by Section 2 of the Housing Acts Amendment Act (Northern Ireland), 1924, and after consultation with the Ministry of Finance for Northern Ireland, by this Order hereby extends, subject to the proviso (b) contained in the said Sub-section 8, the provisions of Sub-section (1) to (7) inclusive of Section 1 of the Housing Act (Northern Ireland), 1923, as amended by Section 2 of the Housing Acts Amendment Act (Northern Ireland), 1924, to the erection of houses in the area defined in the Schedule to this Order:

And the Ministry hereby determines that the grant payable in respect of each house so constructed shall be at the rate of Sixty pounds.

The area comprised within a radius of one statute mile, as measured on a straight line on a six-inch Ordnance Sheet, from the factory chimney of the main works of Messrs. Now therefore the Ministry in pursuance of all powers in that behalf enabling the Ministry hereby authorizes the Guardians of the Poor of Belfast Union to administer out-door relief as aforesaid subject to the conditions set forth in the Ministry's said Order of the 2nd day of February, 1924, for a further period of two months from the 3rd day of April, 1925.
