#### DRAINAGE ACT (NORTHERN IRELAND), 1947 (Reprint to 1952)

ORDER CONFIRMING SCHEME FOR THE RIVER UPPER BANN, COUNTIES ARMAGH AND DOWN

WHEREAS the Ministry of Agriculture for Northern Ireland (hereinafter called "the Ministry") is of the opinion that the execution of drainage works on that part of the River Upper Bann in Counties Armagh and Down, which the Drainage Council for Northern Ireland have determined should be treated as a main watercourse for the purpose of the Drainage Act (Northern Ireland), 1947 (Reprint to 1952) (hereinafter referred to as the "Act") is expedient for the drainage of land in the area of the said river.

And Whereas H. McM. Taggart, B.Sc., M.I.C.E., Chief Engineer of the Ministry of Finance for Northern Ireland, prepared on the 17th April, 1948, on behalf of the Ministry, a report embodying a drainage scheme in accordance with the provisions of Section 4 of the Act for the execution of drainage works on the said river (hereinafter referred to as "the Scheme").

And Whereas on the 9th December, 1958, copies of the Scheme together with an estimate of the cost thereof were sent by the Ministry to the Armagh and Down County Councils and the Portadown Borough Council in accordance with the provisions of Section 5 (1) (a) of the Act and a notice stating that the Scheme had been prepared was duly published in the Belfast Gazette on the 12th December, 1958, and in four newspapers on the 12th December, 1958, and 13th December, 1958, in accordance with the provisions of Section 5 (1) (b) of the Act.

And Whereas the Armagh and Down County Councils and the Portadown Borough Council caused copies of the Scheme to be exhibited in their principal offices during the period from 15th December, 1958, to the 15th January, 1959, inclusive, in accordance with the provisions of Section 5 (2) (a) of the Act.

And Whereas the only authorities charged with the maintenance of any road, bridge or culvert which appears as likely to be affected by the execution of the Scheme are the Armagh and Down County Councils.

And Whereas no observations in regard to the Scheme have been received by the Ministry from the Armagh or Down County Councils.

And Whereas the Ministry has received observations in regard to the Scheme from other interested persons.

And Whereas in accordance with Section 6 (a) of the Act the Ministry has considered the said observations and has made certain alterations in the Scheme in accordance with Section 6 (b) of the Act as set forth in a further report by the said H. McM. Taggart, dated 3rd March, 1959.

Now therefore the Ministry in pursuance of the provisions of Section 6 (c) of the Act, by this Order confirms the Scheme as altered as aforesaid.
