REGULATIONS GOVERNING OPEN COMPETITIONS FOR THE SITUATION OF CLERK IN THE CIVIL SERVICE OF NORTHERN IRELAND

1. Age. If a competition begins in one of the first six months of any year candidates must be of or over the age of 16 and under the age of 25 on the 1st March in that year. If a competition begins in one of the last six months of the year candidates must be of or over the age of 16 and under the age of 25 on the 1st September in that year.

Candidates may, however, deduct from their ages for the purposes of bringing them within the prescribed upper limit:

- (a) any time served in the Royal Navy, the Army or the Royal Air Force or the corresponding
- Women's Services;
  (b) any time, not exceeding two years, served in an established situation in the Civil Service of Northern Ireland.
- 2. Sex. Both men and women may compete under these Regulations. Women candidates must be un-married or widows and if appointed will be required to resign their appointments on marriage.
- 3. Nationality. Candidates must be natural-born or naturalised British subjects. They must also

- (a) have been born in Northern Ireland; or
- (b) have been ordinarily resident
   (i) in the United Kingdom since the 3rd September, 1939; or
  - (ii) in Northern Ireland, either immediately prior to the 1st January, 1940, or for at least ten out of any period of twenty consecutive years ending on or after the 23rd December, 1947; or
- (c) be children of a parent or parents born in Northern Ireland and have been resident in Northern Ireland on the 23rd December,

For the purposes of (b) any period of absence from Northern Ireland or other part of the United King-dom on National Service, whether in H.M. Forces or otherwise, will be disregarded.

Candidates may be exempted from complying with the above requirements as to nationality and/ or residence in exceptional circumstances and where the Commissioners are satisfied that it is in the interests of the public service to grant an exemption.

4. Health and Character. Successful candidates must satisfy the Commissioners as to their health and character.

Note—All persons before being appointed to an established situation in the Civil Service of Northern Ireland are required to undergo a strict medical examination supplemented, when necessary, by an examination by a specialist. The object of the examination is to ascertain whether candidates are physically fit to perform the duties of the post which effective service until they attain the normal age for retiring on pension. Each case is considered on its merits and the Commissioners are not prepared to give prospective decisions on individual cases or to offered further information on the subject other than afford further information on the subject other than to point out that constitutional delicacy, poor physique, diseases of the heart and lungs, defective vision and hearing and persistent albuminuria may be causes for the rejection of a candidate. The Commissioners are empowered under certain conditions to modify the usual standard of physical fitness in favour of persons whose health has been impaired by service in H.M. Forces during war, or who have sustained a war service injury. Where a successful candidate fails on grounds of health to satisfy the Commissioners that he is suitable for appointment to an established situation, the Commissioners may, if they consider that he is capable of performing the duties of the post satisfactorily for a reasonable period, offer him the option of an appointment on the conditions applicable to estabbe causes for the rejection of a candidate. appointment on the conditions applicable to established officers, save in respect of sick leave and superannuation. Candidates appointed on these terms may later secure full establishment if their health record proves satisfactory. Further par-ticulars may be obtained on application to the Commissioners.

Those candidates who, from the statements in their application forms, appear to be eligible will be invited to the written examination. Of the candidates who obtain the highest total marks in the written examination a certain number, to be determined by the Commissioners, will be summoned to the interview which is intended to test the candidate's alertness, intelligence and general outlook, as well as other personal qualities of value for situations in the Civil Service.

The order of merit of the candidates will be determined by combining the marks for written examination and interview.

The number of appointments to be made will be determined by the Commissioners and the Ministry of Finance.

Each candidate will be examined at such time and place as the Commissioners may determine.

- 6. Compulsory Subjects. Candidates must obtain at least 30% of the maximum marks in each of the three compulsory subjects; and an aggregate in these compulsory subjects of at least 40% of the sum of
- 7. Assignment. The Commissioners will decide the Departments to which successful candidates are to be assigned. In making the assignments they will be guided by the requirements of the public service, and candidates may be required to serve anywhere in Northern Ireland. A candidate who does not accept the post offered will have no claim to be assigned to another, but will be regarded as having declined appointment.
- 8. Fees. A fee of 5s. is payable by each candidate. This must be sent with the application form and is not returnable.
- 9. General. No expenses in connection attendance at any part of the competition will be allowed.

No person who is undergoing a course of study with the aid of a grant from public funds shall be eligible to compete before the completion of the course unless he or she has previously obtained permission to do so from the authority which administers the grant.

Candidates must apply on the appropriate form within the time and in the manner of which notice is given by the Commissioners.

Any attempt on the part of candidates to enlist support for their applications through Members of Parliament or other influential persons, except as referees to be named by them in their application forms, will disqualify them for appointment.

Temporal and Commons who are to serve in the said Parliament to be duly returned to and give their Attendance in, Our said Parliament on Tuesday, the twentieth day of October next, which Writs are to be returnable in due course of Law.
