##### TRUNK ROAD IMPROVEMENT AT BRUSLEE, CO. ANTRIM

On 26th February and 5th March, 1959, the Ministry gave notice that it proposed to construct five lengths of new road in substitution for the corresponding lengths of the existing Belfast-Larne Trunk Road in the townlands of Carnall, Lisnalinchy, Bruslee, Little Ballymena, Skilganaban, Legaloy and Dunturky and to make an Order under Section 1 of the Roads Act (Northern Ireland), 1948, the effect of which would be to provide that the lengths of new road would become parts of the trunk road and that after completion of the new lengths the corresponding lengths of the existing road would cease to form part of the Trunk Road.

The Ministry has amended its proposals so far as they relate to the length of new road in the townlands of Skilganaban and Legaloy and in consequence that length of new road will not now be constructed. Improvement will, instead, be carried out to the existing trunk road in these townlands. The Ministry accordingly gives notice that it proposes to modify the proposed Order by the omission of any reference to the said length of new road, but the proposals with regard to the other four lengths of new road are unchanged.

##### BELFAST-BANGOR TRUNK ROAD SYDENHAM BY-PASS

In accordance with the provisions of the First Schedule to the Roads Act (Northern Ireland), 1948, the Ministry of Commerce gives notice that it proposes to make an Order under Section 1 of the Act the effect of which will be as follows:—

1. On the date of the coming into force of the Order the new road known as the Sydenham By-Pass (extending from Newtownards Road at Foundry Street, Belfast, to a point near Tillysburn on the existing trunk road to Bangor) will become part of the Belfast-Bangor Trunk Road (T1).
2. On the first day of April next after the date on which the Ministry gives notice to the Councils of the County Borough of Belfast and of the County of Down that the above new road is opened for through traffic, the length of existing trunk road from its junction with Upper Newtownards Road (A20) in the County Borough of Belfast to a point in the County of Down approximately 300 yards north of its junction with Garnerville Road shall cease to be part of the Belfast-Bangor Trunk Road (T1).
