WAGES COUNCILS ACT (NORTHERN IRELAND), 1945

Linen and Cotton Handkerchief and Household Goods and Linen Piece Goods Wages Council (Northern Ireland)

The Linen and Cotton Handkerchief and Household Goods and Linen Piece Goods Wages Council (Northern Ireland) hereby gives notice of its intention to submit to the Ministry of Labour and National Insurance proposals for (1) the fixing of statutory minimum remuneration in substitution for the statutory minimum remuneration set out in the Linen and Cotton Handkerchief and Household Goods and Linen Piece Goods Wages Council (Northern Ireland) Wages Regulation Order, 1958 (Order N.I.H.H.G. (151)) (S.R. & O. (N.I.) 1958, No. 56), as amended by the Linen and Cotton Handkerchief and Household Goods and Linen Piece Goods Wages Regulation (Amendment) (No. 2) Order (Northern Ireland), 1959, (Order N.I.H.H.G. (157)) (S.R. & O. MINISTRY OF COMMERCE

TRUNK ROAD IMPROVEMENT AT PREHEN, COUNTY LONDONDERRY

STATUTORY RULES AND ORDERS OF NORTHERN IRELAND, 1960, No. 75 URBAN DRAINAGE

RURAL DISTRICT OF ARMAGH

Order, dated 29th April, 1960, made by the Ministry of Agriculture under Section 20(1) of the Urban Drainage Act (Northern Ireland), 1957 (a).

Whereas it appears to the Ministry of Agriculture (hereinafter called "the Ministry") that the density of buildings in that part of the Rural District of Armagh hereinafter referred to is such as to justify that part of the said rural district being designated an urban area for the purposes of the Urban Drainage Act (Northern Ireland), 1957 (hereinafter referred to as "the Act".

Now therefore the Ministry in exercise of the powers conferred upon it by sub-section (1) of section twenty of the Act hereby makes the following order:

- 1. This Order may be cited as the Armagh Rural District (Designation of Urban Drainage Area) Order (Northern Ireland), 1960, and shall come into operation on the date hereof.
- 2. That part of the Rural District of Armagh comprising parts of the townlands of Corporation and Mullynure in the Barony of Armagh and County of Armagh as delineated and coloured green on the Ordnance Survey map sealed with the official seal of the Ministry on the same date as this Order and deposited at the offices of the Ministry at 9 Upper Queen Street, Belfast, is hereby designated an urban area for the purposes of the Act.

EXPLANATORY NOTE

The Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made Regulations under Sections 1 and 5 of the Income Tax (Repayment of Post-War Credits) Act, 1959, viz.:

The Post-War Credit (Income Tax) Amendment Regulations, 1960.

These Regulations prescribe additional qualifications to receive repayment of Post-War Credits.

The new classes who qualify from 16th May, 1960, are set out in Regulation 3 and are :-

- (1) SICKNESS: persons who for a continuous period of 26 weeks ending after 4th April, 1960, have been receiving sickness or industrial injury benefit, or who would have been receiving such benefit but for special arrangements made with their employers, or who have been in-patients in hospitals or nursing homes;
- (2) DISABILITY: persons who after 4th April, 1960, are receiving war or industrial injuries disability pensions in respect of assessments of one hundred per cent., or an allowance under the Workmen's Compensation and Benefit (Supplementation) Act, 1956, or the Workmen's Compensation (Supplementation) Act (Northern Ireland), 1956;
- (3 UNEMPLOYMENT: persons who for a continuous period of 26 weeks ending after 4th April, 1960, have been registered as unemployed;
- (c) WIDOWHOOD: a person who at any time after 4th April, 1960, is a widow.

In groups (1) to (3) the responsible authority, which is defined where necessary under Regulation 2, will certify the facts on which the claim is based.

The Regulations come into force on 16th May, 1960, but no payment of Credits will be made by virtue of these Regulations before 13th June, 1960.

Provision is also made for disregarding intervals up to a total of six days (excluding Sundays) in certifying a continuous period of 26 weeks and for combining periods of sickness, unemployment and national assistance, so as to enable a person to qualify in respect of a total continuous period of 26 weeks.
