WAKEHURST
A PROCLAMATION

For Appointing Tuesday, 12th July, 1960, a Bank Holiday and a Public Holiday in Northern Ireland.

I, John de Vere, Baron Wakehurst, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Governor of Northern Ireland, by and with the advice of the Privy Council of Northern Ireland in pursuance of the Bank Holidays Act, 1871, the Holidays Extension Act, 1875, and the Irish Free State (Consequential Provisions) Act, 1922, and of every power Me thereunto enabling, do hereby appoint Tuesday, the Twelfth day of July, 1960, as a special day to be observed as a Bank Holiday and as a Public Holiday in Northern Ireland, under and in accordance with the said Acts, and I do by this Proclamation command the said day to be so observed, and all loving subjects of Her Majesty to order themselves accordingly.

Given at Government House, Hillsborough, this seventeenth day of May in the year of our Lord, One Thousand Nine Hundred and Sixty.

TRUNK ROAD IMPROVEMENT AT CROMKILL, COUNTY ANTRIM

URBAN DRAINAGE ACT (NORTHERN IRELAND), 1957

ORDER CONFIRMING A DRAFT URBAN DRAINAGE SCHEME FOR THE MILL ROW AREA

WHEREAS the Council of the Armagh Rural District (hereinafter called "the Council"), being duly authorised in that behalf by the Ministry of Agriculture for Northern Ireland (hereinafter called "the Ministry"), prepared a draft urban drainage scheme (hereinafter referred to as "the Scheme"), pursuant to the provisions of the above-mentioned Act for the improvement of drainage at Mill Row, Armagh.

And Whereas the scheme was exhibited at the offices of the Council during the period from 11th March, 1960, to 11th April, 1960, inclusive, and a copy of the scheme was forwarded to the Ministry of Commerce and to other Authorities as required by Sub-Section (1)(a) of Section four of the said Act.

And Whereas, pursuant to the provisions of sub-Section (1)(b) of Section four of the said Act, a notice stating that the scheme had been prepared and further stating as by the said Act required was duly published in one newspaper on the 10th March, 1960, and in the Belfast Gazette on the 4th March, 1960.

And Whereas no observations in regard to the scheme have been received by the Council or the Ministry.

And Whereas, by Order dated the 29th day of April, 1960, made in pursuance of sub-Section (1) of Section twenty of the said Act, the Ministry designated that part of the Rural District of Armagh to which the scheme relates an urban area for the purposes of the said Act.

Now, Therefore, the Ministry, in exercise of the power contained in sub-Section (1) of Section five of the said Act by this Order, confirms the Scheme.
