STATUTORY RULES AND ORDERS OF
NORTHERN IRELAND, 1960, No. 135

POISONS

Order, dated 31st August, 1960, made by the Minister of Home Affairs under sub-section (6) of section twenty-six A of the Medicines, Pharmacy and Poisons Act (Northern Ireland), 1945.

Whereas the Poisons Board, constituted in accordance with section twenty-six of the Medicines, Pharmacy and Poisons Act (Northern Ireland), 1945(a), has recommended to me that the list of the substances which are to be treated as poisons for the purposes of the Pharmacy and Poisons Acts (Northern Ireland), 1925 to 1955, and known as "The Poisons Schedule" for the purposes of those Acts,

should be amended so that certain additional substances should be included in, and certain changes of nomenclature and arrangement made in Part I of the said Schedule (which Part consists of those poisons which, subject to the provisions of the said Act, are not to be sold except by a person who is an authorised seller of poisons) and so that an additional substance should be included in Part II of the said schedule (which Part consists of those poisons which, subject to the provisions of the said Act, are not to be sold except by a person who is an authorised seller of poisons or who is authorised by the local authority).

Now, therefore, I the Right Honourable Brian Faulkner, M.P., Minister of Home Affairs for Northern Ireland, in exercise of the powers conferred on me by sub-section (6) of section twenty-six A of the Medicines, Pharmacy and Poisons Act (Northern Ireland), 1945, and of all other powers enabling me in that behalf do hereby order as follows:—

Citation and commencement

1. This Order may be cited as the Poison List (Amendment) Order (Northern Ireland), 1960, and shall come into operation on the 1st day of October, 1960.

Amendments

2. The Poisons List Confirmation Order (Northern Ireland), 1956(b), (which constitutes "the Poisons Schedule" for the purposes of the Pharmacy and Poisons Acts (Northern Ireland), 1925 to 1955, shall be amended and varied as follows, that is to say:—

(a) Part I shall be amended and varied in the manner specified in the First Schedule,

(b) Part II shall be amended and varied in the manner specified in the Second Schedule, and accordingly the list of substances in the Poisons Schedule which are to be treated as poisons for the purposes of the Pharmacy and Poisons Acts (Northern Ireland), 1925 to 1955, shall be as set out in the Third Schedule.

WAGES COUNCILS ACT (NORTHERN IRELAND), 1945

ROPE, TWINE AND NET WAGES COUNCIL (NORTHERN IRELAND)

The Rope, Twine and Net Wages Council (Northern Ireland) hereby gives notice of its intention to submit to the Ministry of Labour and National Insurance proposals for (1) the fixing of statutory minimum remuneration in substitution for that fixed by the Rope, Twine and Net Wages Council (Northern Ireland) Wages Regulation Order, 1954 (Order N.I.R. (64)) (S.R. & O. (N.I.) 1954, No. 112), as amended by the Rope, Twine and Net Wages Regulation (Amendment) Order (Northern Ireland), 1959 (Order N.I.R. (74)) (S.R. & O. (N.I.) 1959, No. 136) and (2) the revocation of Order N.I.R. (74).

BRUSH AND BROOM WAGES COUNCIL (NORTHERN IRELAND)
