TRUNK ROAD IMPROVEMENT AT MACOSQUIN

The Ministry of Commerce hereby gives notice that it proposes to construct a length of new road in substitution for the corresponding length of the existing Belfast-Coleraine-Londonderry Trunk Road in the townlands of Ardvarness, Camus Macosquin Glebe, Macosquin, Dunderg and Farranlester, Co. Londonderry. In accordance with the provisions of the First Schedule to the Roads Act (Northern Ireland), 1948, the Ministry also gives notice that it proposes to make an Order under Sections 1 and 3 of the Act, the general effect of which will be as follows:—

- The length of new road will become part of the Belfast-Coleraine-Londonderry Trunk Road on the date of coming into force of the Order.
- 2. On the first day of April next after the aforementioned length of new Trunk Road is opened for the purposes of through traffic, the corresponding length of the existing Trunk Road will cease to form part of the Trunk Road.
- Minor alterations and improvements will be made to local roads crossing or joining the new Trunk Road, and a number of junctions between the new Trunk Road and the existing Trunk Road will be stopped up.

The aforementioned works are delineated on a map, a copy of which, together with a copy of the draft Order, may be inspected by any person free of charge at all reasonable hours during a period of 40 days from the 17th day of February, 1961, at the following places:—
