## ALIENS' RESTRICTION ACTS, 1914 AND 1919.

## LAND PURCHASE COMMISSION, NORTHERN IRELAND.

### NORTHERN IRELAND LAND ACT, 1925.

GENERAL NOTICE under Section 17 of the Northern Ireland Land Act, 1925.

To all persons who are entitled to the rents and profits of tenanted land in Northern Ireland, and

To all persons who receive rents and profits of such tenanted land on behalf of any other person.

WHEREAS by Section 8 of the Northern Ireland Land Act, 1925, (hereinafter called "the Act") it is provided that, subject to the provisions of the Act, all tenanted land in Northern Ireland shall on the "Appointed Day" by virtue of the said Act vest in the Land Purchase Commission of Northern Ireland (hereinafter called "the Commission") in the like manner and with the like consequences as if vesting orders had been made on the "Appointed Day" in respect thereof under Section 16 of the Irish Land Act, 1903, in pursuance of new purchase agreements for the purchase of the same at the standard price entered into on the "Appointed Day" by the Commission with persons having power to sell under the Land Purchase Acts.

And whereas by Section 17 of the Act for the purpose of ascertaining the land which is to be vested in the Commission it is provided, among other things, that it shall be the duty of every person who is entitled to the rents and profits of any land or who receives such rents and profits on behalf of any other person, if so required by the Commission, to furnish in writing to the Commission such information, maps, particulars and documents with respect to the land in such form and verified in such manner and within such time as the Commission may by a general or special notice require.

And whereas by Section 20 of the Act the expression "tenanted land" means land held for a statutory term or under any contract of tenancy other than a fee-farm grant, or lease for lives or years renewable for ever, or lease for a term of years of which sixty or more are unexpired: Provided that land which has become tenanted land,

as above defined, by reason of a contract of tenancy entered into on or after the sixteenth day of December, 1924, shall be deemed not to be tenanted land for the purposes of Part II of the Act.

And whereas by Rules dated the 29th day of May, 1925, made by the proper authority under the powers of the Act, the particulars which are required to be furnished pursuant to the Act are stated, and it is further provided that these particulars are to be furnished in the Forms therein referred to, and are to be lodged with the Commission within the time therein specified.

And whereas by Section 17 of the Act it is provided that if any person fails to furnish any information, map, particular, or document which he is required to furnish under such Section or knowingly furnishes any information, map, particular, or document which is false in any material particular, he shall on summary conviction be liable to a fine not exceeding fifty pounds or to imprisonment for a term not exceeding three months, and where any information, map, particular, or document required by such section to be given by or on behalf of a person entitled to the rents and profits of any land is not given within the time required by the Commission no bonus or interest thereon shall be payable in respect of the land unless or to such extent as the Commission consider that the failure ought to be excused.

Now the Commission hereby give Notice that all Persons who are entitled to the rents and profits of any tenanted land in Northern Ireland and all persons who receive rents and profits of such tenanted land on behalf of any other person are hereby required to furnish in writing on or before the 1st day of October, 1925, to the Land Purchase Commission, Northern Ireland, at their Office, Northern Bank Buildings, May Street, Belfast, such information, maps, particulars and documents with respect to such land in the forms and verified in such manner as have been prescribed by the said Rules.

Now, therefore, the Ministry, in pursuance of all powers in that behalf enabling the Ministry, hereby authorise the Guardians of the Poor of Belfast Union to administer out-door relief as aforesaid, subject to the conditions set forth in the Ministry's said Order of the 2nd day of February, 1924, for a further period of two months from the 3rd day of June, 1925.

##### PROHIBITION OF TRAFFIC.

##### ROADS ACT, 1920.

WHEREAS the Council of the County of Armagh has made an application to the Ministry of Home Affairs for Northern Ireland for an Order prohibiting the driving of locomotives and heavy motor cars on the following roads :—

- (1) Between Kishacreen Bridge and the Argory Bridge ;
- (2) Between Tullyroan Corner and Verner's Bridge ;
- (3) Between Annaghmore Railway Station and the Portadown to Dungannon Road at Derryhubbert ;

(4) Between Kishacreen Bridge and Charlemont; Provided that nothing in the Order shall prevent the driving upon the said roads of :—

- (a) Any vehicle which is being used for the purposes of agriculture in connection with land adjoining or lying near to said roads, or for the conveyance or haulage of timber felled upon such land ; and
- (b) any vehicle which is being used for the conveyance of goods or merchandise to or from any house, building, or other premises situate on or adjacent to the said roads.

Now, therefore, the Ministry of Home Affairs for Northern Ireland has appointed John Bates, Esq., M.I.C.E.I., Engineering Inspector to the Ministry, to hold a local inquiry into the said application in the Courthouse, Armagh, on Wednesday, the 1st day of July, 1925, at 11 o'clock a.m.

Any person interested may attend and be heard at the inquiry, provided he has not later than the 27th instant notified in writing to the Ministry his intention to do so.
