(b) Claims by British nationals against the Austrian Government with the payment of which the property rights and interests within His Majesty's Dominions or Protectorates belonging to nationals of the former Austrian Empire at the date when the said Treaty came into force (not being property rights or interests acquired under any general licence issued by or on behalf of His Majesty) and the net proceeds of their sale, liquidation or other dealings therewith are charged by Article 1 (ix) of the above-mentioned Orders in Council:

must be made upon the prescribed Forms and lodged with this Department, in order to rank for payment of the fifth dividend to be declared by me out of the funds in my hands arising from the liquidation of the above-mentioned property rights and interests belonging to nationals of the former Austrian Empire, or received by me from the Austrian Clearing Office, under paragraph 11 of the Annex to Article 248 of the above-mentioned Treaty, in pursuance of the Note of His Majesty's Government to the Austrian Government of the 27th August, 1920, published in the London Gazette

of the 15th October, 1920 (No. 32086), or arising out of any other available property.
