### THE MINISTRY OF HOME AFFAIRS FOR NORTHERN IRELAND.

### The Local Government Acts (Northern Ireland), 1898 to 1922.

COUNTY BOROUGH OF LONDONDERRY.

To the Mayor, Aldermen and Burgesses of the Borough of Londonderry, and to all others whom it may concern:

WHEREAS it is enacted by Section 3 of the Local Government Act (Northern Ireland), 1922 (hereinafter referred to as "the Act") that the Ministry of Home Affairs for Northern Ireland (hereinafter referred to as "the Ministry") on request made by a resolution of the council of any borough passed by a majority of the members voting on such resolution may, if it thinks fit, by order apply to the borough in lieu of the provisions relating to triennial elections or elections of Aldermen which are contained in the Local Government (Ireland) Act, 1919, as amended by the Act, the enactments which were in force immediately before the commencement of the Local Government (Ireland) Act, 1919, with respect to the election and retirement in rotation of borough councillors and aldermen (which enactments are hereinafter referred to as "the former enactments") and make such incidental provisions as appear to the Ministry necessary or expedient for bringing such application into full effect, including provisions with respect to the term of office of the aldermen and the holding of separate elections of aldermen :

And Whereas the provisions of Section 15 of the Londenderry Improvement Act, 1896 (hereinafter referred to as "the Act of 1896 ") as amended by the Local Government (Ireland) Act, 1898, are the former enactments with respect to the election and retirement in rotation of borough councillors and aldermen for the county borough of Londonderry, and a request has been made to the Ministry by a resolution of the council of the county borough of Londonderry, which resolution was passed by a majority of the members voting thereon, to make an order applying to the said county borough the former enactments:

And Whereas by the Act of 1896 the said county borough of Londonderry is divided into five wards, called respectively the East Ward, the North Ward, the South Ward, the Waterside Ward, and the West Ward, the boundaries of which are defined in the said Act, and the number of members to be elected for the said Wards is ten aldermen and thirty councillors, or forty members:

And Whereas in pursuance of the provisions of Section 7 of the Act, the Ministry, by Order under Seal, did, on the 6th day of November, 1922, direct that the members of the council of the said (county borough of Londonderry should be elected for the said five Wards, and by the said Order apportioned the borough councillors and aldermen among the said Wards.

And Whereas the Ministry has consulted with the council of the said county borough of Londonderry and considered any representations made by the said council:

And Whereas the Ministry does not deem it necessary to hold any local Inquiry into the matters aforesaid:

Now, Therefore, the Ministry in exercise of the powers vested in it by the Act and of all other powers in this behalf enabling the Ministry hereby orders and directs that, notwithstanding anything to the contrary contained in the the Order of the 6th day of November, 1922, for the purpose of the election of aldermen and councillors for the county borough of Londonderry, to be held on the 15th day of January, 1926, and of all subsequent elections the following provisions shall be observed and have effect:—

- 1. The former enactments, subject to the provisions hereinafter appearing with respect to the election and retirement in rotation of borough councillors and aldermen, shall apply to the county borough of Londonderry in lieu of the provisions relating to triennial elections which are contained in the Local Government (Ireland) Act, 1919.
- 2. The aldermen and councillors of the county borough of Londonderry in office on the 15th day of January, 1926, shall retire on the 16th day of January, 1926.
- 3. On the 15th day of January, 1926, there shall be elected two aldermen and six councillors for each of the said five wards into which the county borough of Londonderry was divided by the Act of 1896.
- 4. (a) In each ward one of the two aldermen elected on the 15th day of January, 1926, shall go out of office on the 16th day of January, 1929, and the remaining one on the 16th day of January, 1932, and the alderman who is to retire in the first instance in each of the five wards shall be the alderman who was elected in that ward by the smallest number of votes at the first election the majority of the whole council, always determining when the votes for any such aldermen shall have been equal or when there shall have been no contest, who shall be the aldermen to go out of office; provided always that any alderman on going out of office may be forthwith reelected if duly qualified.
  - (b) In each ward two of the six councillors elected on the 15th day of January, 1926, shall go out of office on the 16th day of January, 1927, two more shall go out of office on the 16th day of January, 1928, and the remaining two shall go out of office on the 16th day of January, 1929; and the order of retirement of such councillors individually shall be determined by the number of votes received by them respectively at their election in the year 1926, the two councillors having the lowest

number of votes retiring in the year 1927, the two councillors having the next lowest number of votes retiring in the year 1928, and the two councillors having the highest number of votes remaining in office till the year 1929, the majority of the whole council always determining when the votes for any such councillors shall have been equal or when there shall have been no contest, who shall be the councillors to go out of office; provided always that any councillor so going out of office shall be capable of being forthwith re-elected if duly qualified.

- 5. The vacancy caused by the going out of office of any alderman or councillor of a ward in manner as aforesaid shall be filled by the election of an alderman or councillor who shall not remain in office more than six years or three years, respectively, without being re-elected.

### BY-LAW.

### No. 16, OR BALLYCASTLE DISTRICT.

I, William Joynson-Hicks, one of His Majesty's Principal Secretaries of State, by virtue and in exercise of the powers and authorities vested in me by the above recited Acts and of every other power enabling me in this behalf—

1. Do hereby repeal the By-law dated 19th September, 1898, by which it is prohibited to have in possession for the purpose of taking fish, or with the intent to take fish, between Sunrise and Sunset, at any Season of the year, in or on the Banks of the River Bush and its tributaries, inside the defined mouth of the said River Bush in the No. 16 or Ballycastle District, or on Mill Dams or Weirs on said River and tributaries, any Spear, Lyster, Strokehaul, Gaff, or any part or portion of a Gaff (except a Gaff for the purpose of being used solely as auxiliary to fishing legally with rod and line).

2. And do hereby make and ordain this By-law, by which it is prohibited, and it is hereby prohibited, to have in possession for the

purpose of taking fish or with the intent to takefish, between Sunrise and Sunset, at any Season of the year, in or on the Banks of the Upper or Fresh Water portions of all Rivers and their tributaries in the said No. 16 or Ballycastle District, or on Mill Dams or Weirs on said portions of said Rivers, any Spear, Lyster, Strokehaul, Gaff, or any part or portion of any such instrument (except a Gaff for the purpose of being used solely as auxiliary to fishing legally with rod and line).

Each and every person convicted of an offence against this By-law shall forfeit and pay for each offence a sum of Four Pounds, and every Spear, Lyster, Strokehaul, Gaff, or any part or portion of any such instrument found in possession at the time and in the places during and in which it is hereby prohibited to have such Spear, Lyster, Strokehaul, Gaff, or any part or portion of any such instrument in possession shall be forfeited.
