for the purposes of through traffic, the corresponding length of the existing Trunk Road will cease to form part of the Trunk Road.

3. The Ministry will be authorised to stop up the junction which will exist between the old and new Trunk Roads on the north side of the junction of the First Class Road A.34 with the existing Trunk road.
