TRUNK ROAD IMPROVEMENT AT BALLYMACILROY, COUNTY TYRONE

The Ministry of Commerce hereby gives Notice that it proposes to make an Order under Section 3(5) of the Roads Act (Northern Ireland), 1948, the effect of which will be to authorise the abandonment of a number of lengths of the Belfast-Ballygawley-Londonderry Trunk Road (T.3) in townlands of Shantavny Scotch, Glenchuil and Sess Kilgreen, in the County of Tyrone.
