A PROCLAMATION

URBAN DRAINAGE ACT (NORTHERN IRELAND), 1957

ORDER CONFIRMING A DRAFT URBAN DRAINAGE SCHEME FOR THE IMPROVEMENT OF DRAINAGE IN THE NEWRY AREA

Whereas the Council of the Urban District of Newry (hereinafter called "the Council") being duly authorised in that behalf by the Ministry of Agriculture for Northern Ireland (hereinafter called "the Ministry") prepared a draft urban drainage scheme (hereinafter referred to as "the Scheme") pursuant to the provisions of the above mentioned Act for the diversion of the headwaters of the Derrybeg Stream to the Bessbrook River, the culverting of the Glen Stream from the Dublin Road Bridge to the existing Canal syphon and the culverting of the Cloghoe Stream from a point in the grounds of Drumalane House to the existing Canal syphon.

And Whereas the Scheme was exhibited at the offices of the Council during a period of one month from 1st October, 1959, and a copy of the Scheme was forwarded to the Ministry of Commerce and to other Authorities as required by sub-section (1) (a) of Section four of the said Act.

And Whereas pursuant to the provisions of sub-section (1) (b) of Section four of the said Act a notice stating that the Scheme had been prepared and further stating as by the said Act required was duly published in two newspapers on 26th September, 1959, and in the Belfast Gazette on 25th September, 1959.

And Whereas certain observations in regard to the Scheme have been received by the Council and the Ministry.

And Whereas in accordance with sub-section (1) of Section five of the said Act the Ministry has considered the said observations and considers that modifications should be made to the Scheme which said modifications are set forth in a supplementary Report dated 18th May, 1961, issued by Messrs. Munce and Kennedy, Consulting Engineers to the Council.

Now, Therefore, the Ministry in exercise of the power contained in sub-section (1) of Section five of the said Act by this Order confirms the Scheme as

modified in the said supplementary Report which Scheme so modified is estimated to cost £40,050.
