District Electoral Division:

4. The original Templecorran Division together with the portion of the original Whitehead Division not included within the boundary of the Town of Whitehead shall be constituted a District Electoral Division, and shall be named the Templecorran District Electoral Division:

And it is hereby declared that the foregoing provisions of this Order shall in no way affect or be deemed to affect the limits of any area heretofore determined by any Order to be the area of charge upon which any special expenses as defined by Section 232 of the Public Health (Ireland) Act, 1878, or any other expenses directed by any Act to be defrayed as such special expenses are and shall be chargeable.

WE, the Lords Justices of Northern Ireland, by and with the advice of the Privy Council of Northern Ireland, in pursuance of the Bank Holidays Act, 1871, the Holidays Extension Act, 1875, and the Irish Free State (Consequential Provisions) Act, 1922, and of every power Us thereunto enabling, do hereby appoint Monday, the thirteenth day of July next, as a special day to be observed as a Bank Holiday and as a Public Holiday in Northern Ireland, under and in accordance with the said Acts, and We do, by this Proclamation, command the said day to be so observed, and all loving subjects of His Majesty to order themselves accordingly.
