A PROCLAMATION

FOR APPOINTING MONDAY, JULY 13, 1925,
A BANK HOLIDAY AND A PUBLIC HOLIDAY
IN NORTHERN IRELAND.

WE, the Lords Justices of Northern Ireland,
by and with the advice of the Privy Council of

Northern Ireland, in pursuance of the Bank Holidays Act, 1871, the Holidays Extension Act, 1875, and the Irish Free State (Consequential Provisions) Act, 1922, and of every power Us thereunto enabling, do hereby appoint Monday, the thirteenth day of July next, as a special day to be observed as a Bank Holiday and as a Public Holiday in Northern Ireland, under and in accordance with the said Acts, and We do, by this Proclamation, command the said day to be so observed, and all loving subjects of His Majesty to order themselves accordingly.

Given at the Council Chamber, Belfast, this twenty-ninth day of June, in the Year of our Lord, One thousand nine hundred and twenty-five.
