The Poisons (No. 2) Regulations provide that a

purchase by the Ministry of Home Affairs for the purpose of securing compliance with the provisions of Part III of the Pharmacy and Poisons Act (Northern Ireland), 1945, shall be deemed not to be a purchase within the meaning of paragraph (b) of sub-section (5) of Section 29 of the Act.
