TRADE BOARDS ACT (NORTHERN IRELAND), 1923.

DRESSMAKING AND WOMEN'S LIGHT CLOTHING TRADE BOARD (NORTHERN IRELAND).

The Trade Board established by the Ministry of Labour for Northern Ireland under the powers conferred on it by the Trade Boards Act (Northern Ireland) 1923, for the Dress-making and Women's Light Clothing Trade in Northern Ireland as defined in the Schedule to the Trade Boards (Dressmaking and Women's Light Clothing Trade, Northern Ireland) (Constitution, Proceedings and Meetings) Regulations, 1925, dated 20th May, 1925, hereby give notice that they propose to vary minimum rates of wages for female workers employed in the Retail Bespoke Dressmaking Branch of the trade.

On request to the Trade Board particulars of the proposed variation of minimum rates will be given if, in the opinion of the Trade Board, the applicant is likely to be affected thereby.

The Trade Board will consider any objections to their proposals which may be lodged with them within fourteen days from the Sixteenth day of July, 1925.
