ORDER CONFIRMING SCHEME FOR THE UPPER BANN RIVER, COUNTY DOWN.

WHEREAS the Ministry of Agriculture for Nor-thern Ireland (hereinafter called "the Ministry") is

of the opinion that the execution of drainage works on that part of the Upper Bann River in County Down, which the Drainage Council for Northern Ire-land have determined should be treated as a main watercourse for the purpose of the Drainage Act (Northern Ireland) 1947 (Reprint to 1952) (herein-after referred to as "the Act") is expedient for the drainage of land in the area of the said river.

And Whereas H. McM. Taggart, B.Sc., M.I.C.E., Chief Engineer, of the Ministry of Finance for Nor-thern Ireland, prepared on 19th December, 1960, on behalf of the Ministry a report embodying a drain-age scheme in accordance with the provisions of Section 4 of the Act for the execution of drainage works on the said river (hereinafter referred to as "the scheme") 'the scheme").

And Whereas on 4th August, 1961, copies of the Scheme together with an estimate of the cost thereof were sent by the Ministry to the Down County Council and Banbridge Rural District Council in accordance with the provisions of Section 5 (1) (a) of the Act and a notice stating that the Scheme had been prepared was duly published in the Belfast Gazette on 11th August, 1961, and in four newspapers during the week ending 12th August, 1961, in accordance with the provisions of Section 5 (1) (b) of the Act.

And Whereas the Down County Council caused copies of the Scheme to be exhibited in their prin-cipal offices and at the offices of the Banbridge Rural District Council during the period from 11th August to 11th September, 1961, inclusive, in accordance with the provisions of Section 5 (2) (a) of the Act.

And Whereas the authorities charged with the maintenance of any road, bridge or culvert which appears as likely to be affected by the execution of the Scheme are Down County Council, Ulster Trans-port Authority, Banbridge Urban District Council, and the Hazelbank Weaving Company.

And Whereas no observations in regard to the Scheme have been received by the Ministry from the Down County Council, Ulster Transport Authority, Banbridge Urban District Council or Hazelbank Weaving Company.

And Whereas the only observations received in regard to the Scheme from interested persons have been considered in accordance with Section 6 (a) of the Act.

Now Therefore the Ministry in pursuance of the provisions of Section 6 (c) of the Act by this Order confirms the Scheme.
