URBAN DRAINAGE ACT (NORTHERN IRELAND), 1957

ORDER CONFIRMING A DRAFT URBAN DRAINAGE Scheme for the Improvement of Drainage in Dromore, Co. Tyrone

WHEREAS the Council of the Omagh Rural District (hereinafter called "the Council"), being duly authorised in that behalf by the Ministry of Agriculture for Northern Ireland (hereinafter called "the Ministry") prepared a draft urban drainage scheme (hereinafter referred to as "the Scheme") pursuant to the provisions of the above-mentioned Act for the improvement of drainage in Dromore.

And Whereas the scheme was exhibited at the offices of the Council during a period of one month from 18th May, 1962, and a copy of the Scheme was forwarded to the Ministry of Commerce and to Tyrone County Council as required by sub-section (1) (a) of section four of the said Act.

And Whereas pursuant to the provisions of subsection (1) (b) of section four of the said Act a notice stating that the Scheme had been prepared and further stating as by the said Act required was duly published in one newspaper on the 18th May, 1962, and in one newspaper on 19th May, 1962, and also in the Belfast Gazette on 18th May, 1962.

And Whereas no observations in regard to the Scheme have been received by the Council or the Ministry.

And Whereas by Order dated 28th June, 1962, made in pursuance of sub-section (1) of section twenty of the said Act the Ministry designated part of the Rural District of Omagh to which the Scheme relates an urban area for the purposes of the said Act.

Now Therefore the Ministry in exercise of the power contained in sub-section (1) of section five of the said Act by this Order confirms the scheme.
