WHEREAS the Council of the County Borough of Belfast have submitted to Us a Closing Order (No. 10) made by the said Council on the 2nd day of June, 1925, in pursuance of the provisions of the Shops Act, 1912, 2 George V, Chapter 3, fixing the hours at which all shops in the County Borough of Belfast in which the trade or business of a Watchmaker or Jeweller is carried on shall be closed for the serving of customers on the several days of the week:

WHEREAS on the 1st day of September, 1914, the Council of the County Borough of

Belfast made a Closing Order (No. 3) in pursuance of the provisions of the Shops Act, 1912, 2 George V, Chapter 3, fixing the hours on the several days of the week at which all Watchmakers' or Jewellers' shops in the County Borough of Belfast should be closed for serving customers:

Now, We, The Lords Justices of Northern Ireland, in pursuance of the powers conferred upon Us by the Shops Act, 1912, 2 George V, Chapter 3, and of every other power enabling Us in this behalf, Do Hereby revoke the said Closing Order (No. 3) made by the Council of the County Borough of Belfast on the 1st day of September, 1914, and confirmed on the 19th day of October, 1914.
