# TREASURY

#### **IMPORT DUTIES ACT, 1958**

The Lords Commissioners of Her Majesty's Treasury hereby give notice that They have made an Order under Sections 9 and 13 of, and Schedule 5 to, the Import Duties Act, 1958, viz:-The Import Duty Drawbacks (No. 4) Order, 1963.

This Order:

- (i) extends until 31st July 1964 the provision of drawback of import duty on creped paper used in the manufacture of exported adhesive tape;
- (ii) provides for the alteration of the rates of drawback of import duty on certain imported cellulose paper used in the manufacture of certain exported electrosensitive recording paper;
- (iii) revokes the existing provision for drawback of import duty on imported wooden veneer sheets used in the manufacture of sewing machine bases for export, and varies the rates of drawback of import duty of certain imported square sawn wood and timber and wooden veneer sheets used in the manufacture of specified exported sewing machine woodwork.

The Order comes into operation on the 3rd July, 1963, and has been published as Statutory Instruments 1963, No. 1139.

The Lords Commissioners of Her Majesty's Treasury hereby give notice that They have made an Order under Sections 1, 2 and 13 of the Import Duties Act, 1958. viz:-The Import Duties (General) (No. 5) Order, 1963.

This Order:

- (i) reduces the full and E.F.T.A. rates of import duty on hothouse grapes during the period 1st February to 30th June;
- (ii) varies the full and E.F.T.A. rates of import duty on hothouse peaches and nectarines during the period 1st April to 31st October by substituting ad valorem rates for the existing specific rates;
- (iii) further reduces the full rate of import duty (and proportionately the Commonwealth preference rate) on certain motor vehicles and certain motor vehicle parts and accessories in accordance with the undertakings given by the United Kingdom at Geneva and set out in the July 1962 Protocol to the General Agreement on Tariffs and Trade.

#### WILD BIRDS PROTECTION ACTS (NORTHERN IRELAND) 1931 AND 1950
