TREASURY

IMPORT DUTIES ACT 1958

The Lords Commissioners of Her Majesty's Treasury hereby give notice that They have made an Order under Sections 3 (6) and 13 of the Import Duties Act, 1958, viz:—The Import Duties (Temporary Exemptions) (No. 1) Order 1964.

This Order provides for the temporary exemption from import duty of S-2: 3: 3-Trichloroallyl disopropylthiocarbamate (Tariff heading 29.31) and Sulphamethoxazole (Tariff heading 29.36) until 1st January 1965, and of certain steel in coils (Tariff heading 73.15) until 18th March, 1964.

The Order comes into operation on the 24th January, 1964, and has been published as Statutory Instruments 1964, No. 52.

TRUNK ROAD IMPROVEMENT AT BROOKEBOROUGH-KILLARTRY, CO. FERMANAGH

The Ministry of Home Affairs hereby gives notice that it proposes to construct a length of new road in substitution for the corresponding length of the Ballygawley-Enniskillen Trunk Road in the townlands of Killykeeran, Killartry, Drumee, Lurgan and Tattendillur in the County of Fermanagh.
