TRADE BOARDS ACT (NORTHERN IRELAND), 1923.

DRESSMAKING AND WOMEN'S LIGHT CLOTHING TRADE BOARD (NORTHERN IRELAND).

The Trade Board established by the Ministry of Labour for Northern Ireland, under the powers conferred on it by the Trade Boards Act (Northern Ireland), 1923, for the Dressmaking and Women's Light Clothing Trade in Northern Ireland, as defined in the Schedule to the Trade Boards (Dressmaking and Women's Light Clothing Trade, Northern Ireland) (Constitution, Proceedings and Meetings) Regulations, 1925, dated 20th May, 1925, hereby give notice that they propose to vary and to cancel minimum rates of wages for certain classes of male and female workers in the said trade.
