WIDOWS' ORPHANS' AND OLD AGE CONTRIBUTORY PENSIONS ACT (NORTHERN IRELAND), 1925.

The Ministry of Labour for Northern Ireland hereby gives notice that Regulations have been made under Section 32 of the Widows', Orphans' and Old Age Contributory Pensions Act (Northern Ireland), 1925, providing for the exercise and performance by the National Health Insurance Joint Committee, either alone or jointly with the Ministry of Labour, of such powers and duties of the Ministry of Labour under the said Act as are specified in the Regulations.
