#### PREMIUM SAVINGS BONDS—NEW £25,000 PRIZE

#### DANGEROUS DRUGS

(N.I.) 1965, No. 30). In addition provision is made for inserting "Nicocodine," hitherto subject to full control under the principal Regulations, into the Second Schedule (i.e., drugs which are subject to control modified in certain respects: in particular, they can be obtained from an authorised seller of poisons without a prescription).
